**Dear Parent/Carer** 

In January 2019, a team of inspectors from Education Scotland and the Care Inspectorate visited St Francis Xavier's RC Primary School and Nursery Class. During our visit, we talked to parents/carers and children and worked closely with the headteacher and staff.

The inspection team found the following strengths in the school's work.

- The outstanding leadership of the headteacher resulting in a school where staff and children enjoy learning together. She is ably supported by a very effective depute headteacher. Together they have created a strong staff team where staff and children are motivated to learn in a supportive, nurturing environment.
- Confident well behaved children who are enthusiastic about their learning and proud of their school.
- The strong approaches to developing staff skills and confidence through quality professional learning. Staff are also encouraged to undertake further study and lead developments across the school and cluster of schools. This is resulting in high quality teaching and learning in most lessons across the school.
- The highly effective TP room is a popular resource used by all children to support their social and emotional development. As a result almost all children are very settled and engaged in the learning.
- Staff across the school provide a range of highly effective support to help children who have barriers to learning achieve. As a result, children who experience challenges in their learning are making very good progress towards their targets.
- Staff have effective arrangements in place to plan learning, teaching and assessment across all curricular areas. There are effective approaches to monitor and track children's progress in their learning. As a result attainment across the curriculum is very good.

The following areas for improvement were identified and discussed with the headteacher and a representative from Falkirk Council.

- Continue to ensure the examples of high quality learning and teaching are shared across the school.
- Continue to build on work already begun to improve attainment in writing.
- The nursery practitioners should work together as a team, involving children, parents and the community to develop the improvement priorities for the nursery.





We gathered evidence to enable us to evaluate the school's work using four quality indicators from <u>How good is our school?</u> (4<sup>th</sup> edition) and <u>How good is our early learning and childcare?</u>. Quality indicators help schools, local authorities and inspectors to judge what is working well and what needs to be improved. Following the inspection of each school, the Scottish Government gathers details of our evaluations to keep track of how well Scottish schools are doing.
