Dear Parent/Carer

In November 2018, a team of inspectors from Education Scotland and the Care Inspectorate visited Monquhitter School and Nursery Class. During our visit, we talked to parents/carers and children and worked closely with the headteacher and staff.

The inspection team found the following strengths in the school's work.

- Led by the headteacher, high quality staff team collaboration across all stages of the school and nursery. Commitment of all to professional learning and development to support school improvement in a environment which is nurturing and encouraging.
- Articulate children whose behaviour is exemplary. They are proud of their school, enthusiastic and engaged in their learning.
- The improvement in childen's reading skills and their increased enjoyment in reading.

The following areas for improvement were identified and discussed with the headteacher and a representative from Aberdeenshire Council.

- As the school continues to develop learning and teaching, staff should focus on developing children's skills in leading their own learning. There is a need for a structured approach to support children to become more independent in their learning, talk about their learning and be clear about their next steps.
- Continue to improve children's attainment in writing. In doing so, review the development of writing as planned and undertake further moderation activities to ensure there is a shared understanding of required standards of writing across the school.
- To improve attainment in numeracy, continue to focus on the development of mental agility and problem solving skills across the school.
- The school and nursery should continue to develop and streamline planning processes to record children's learning journey.





We gathered evidence to enable us to evaluate the school's work using quality indicators from How good is our school? (4th edition) and How good is our early learning and childcare?. Quality indicators help schools, local authorities and inspectors to judge what is working well and what needs to be improved. Following the inspection of each school, the Scottish Government gathers details of our evaluations to keep track of how well Scottish schools are doing.
