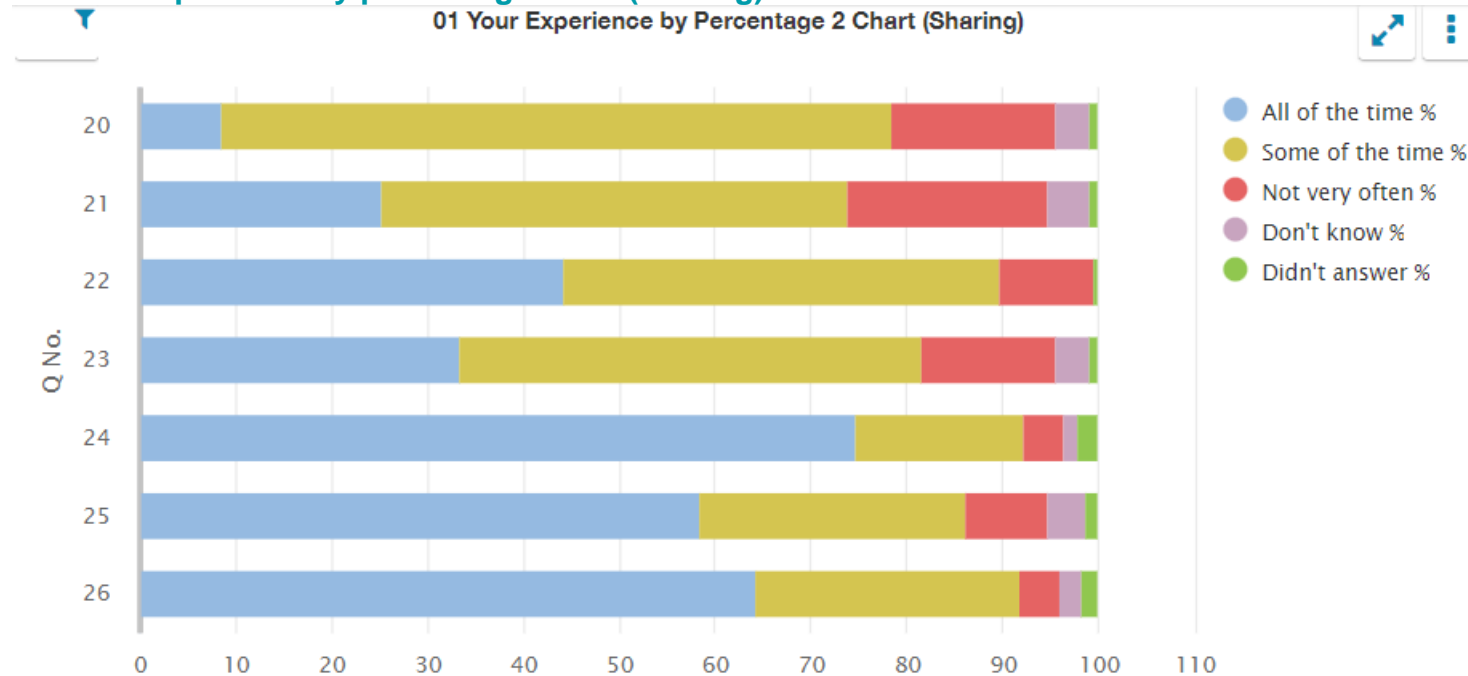

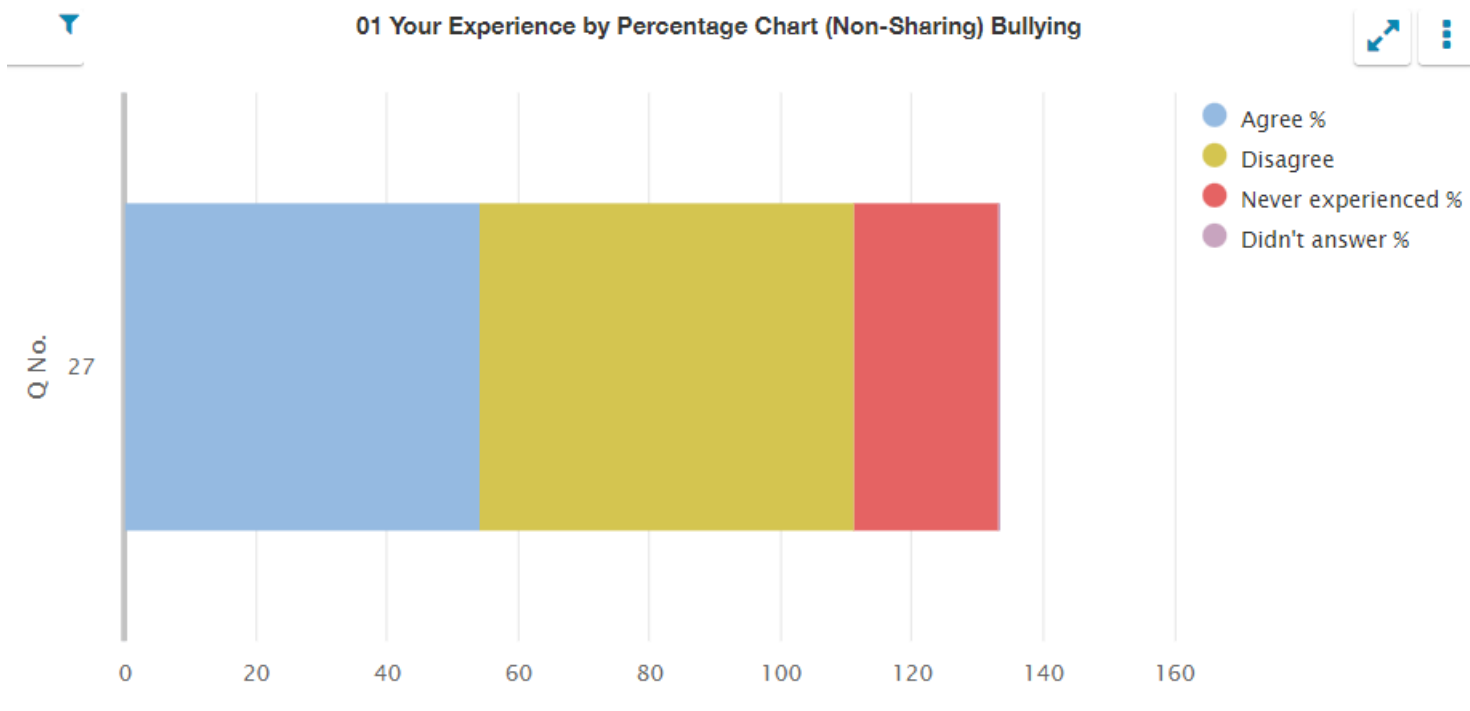

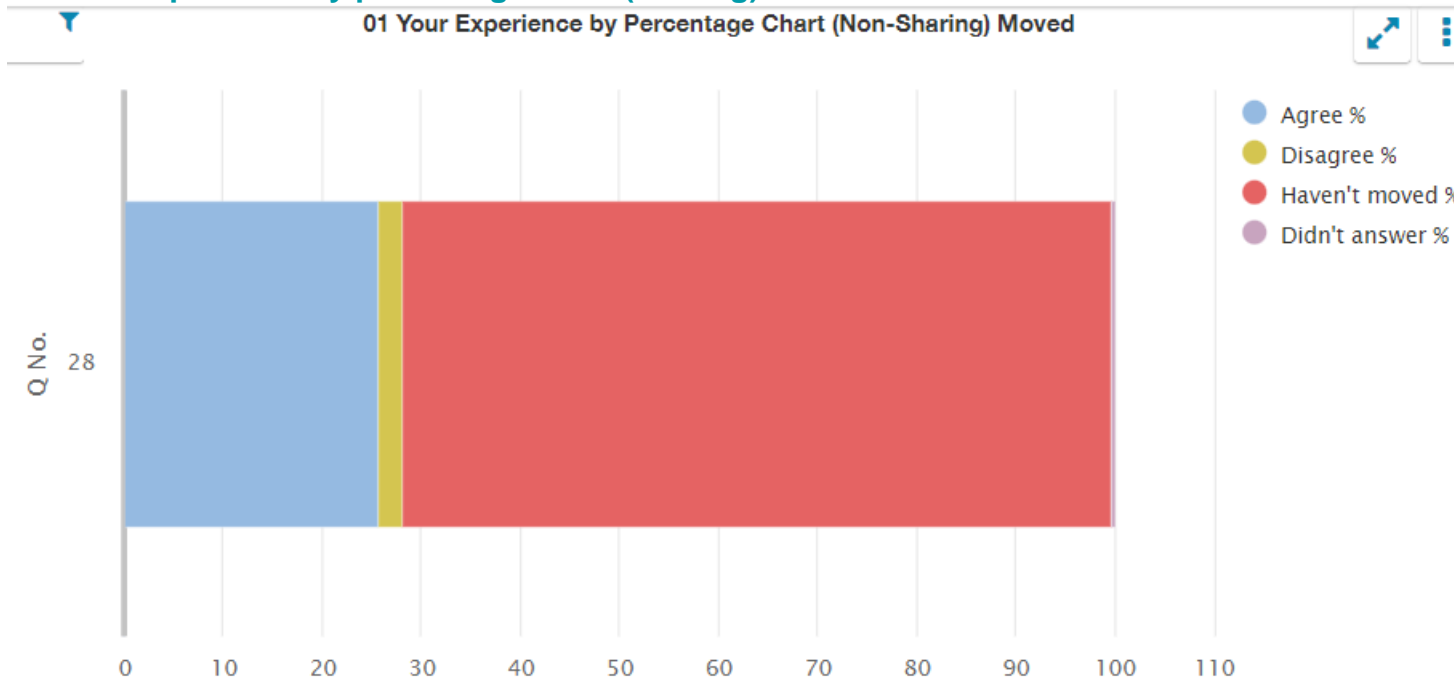
01 Your experience by percentage chart (sharing) bullying

01 Your experience by percentage chart (sharing) moved



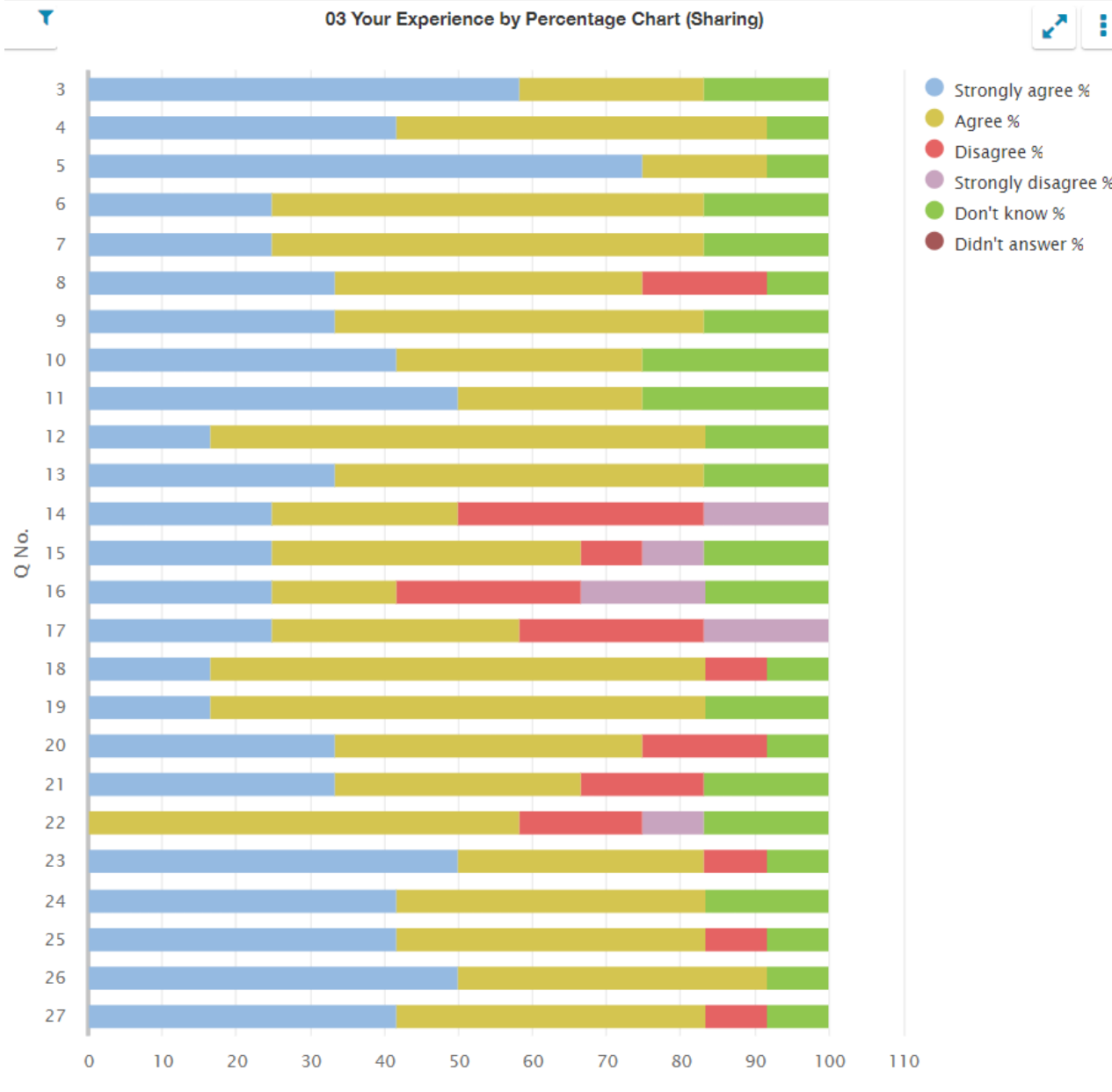

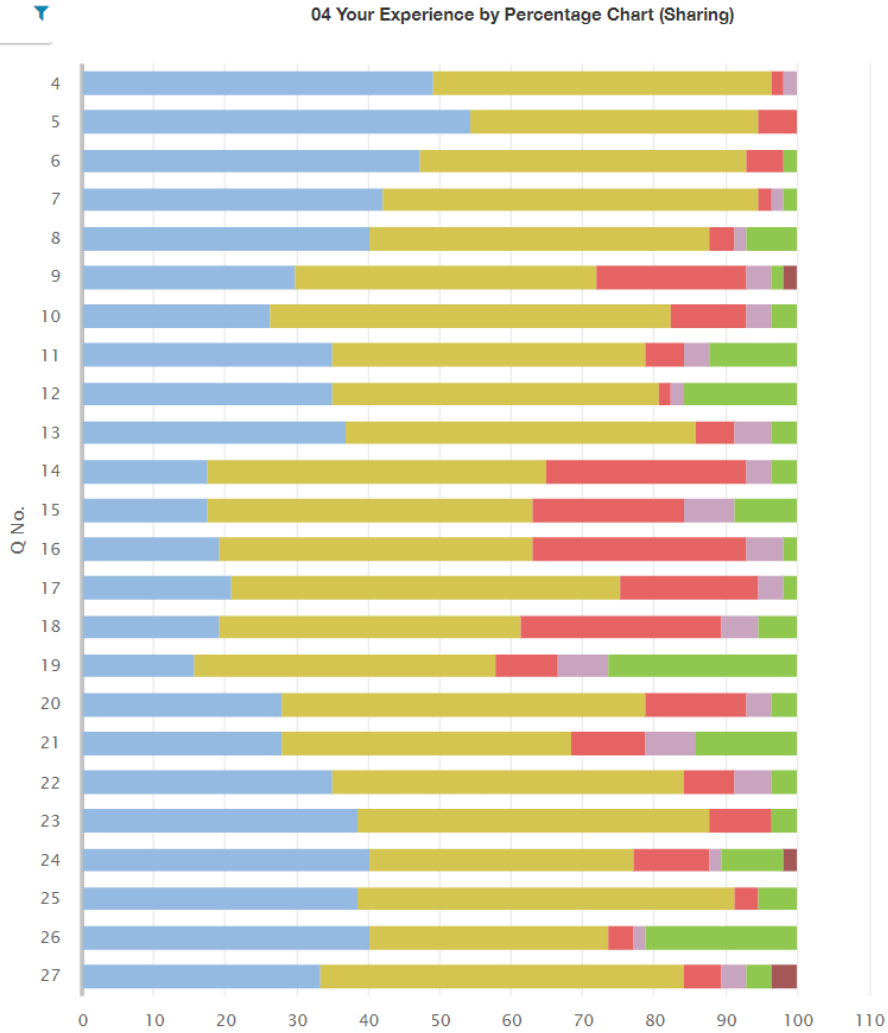

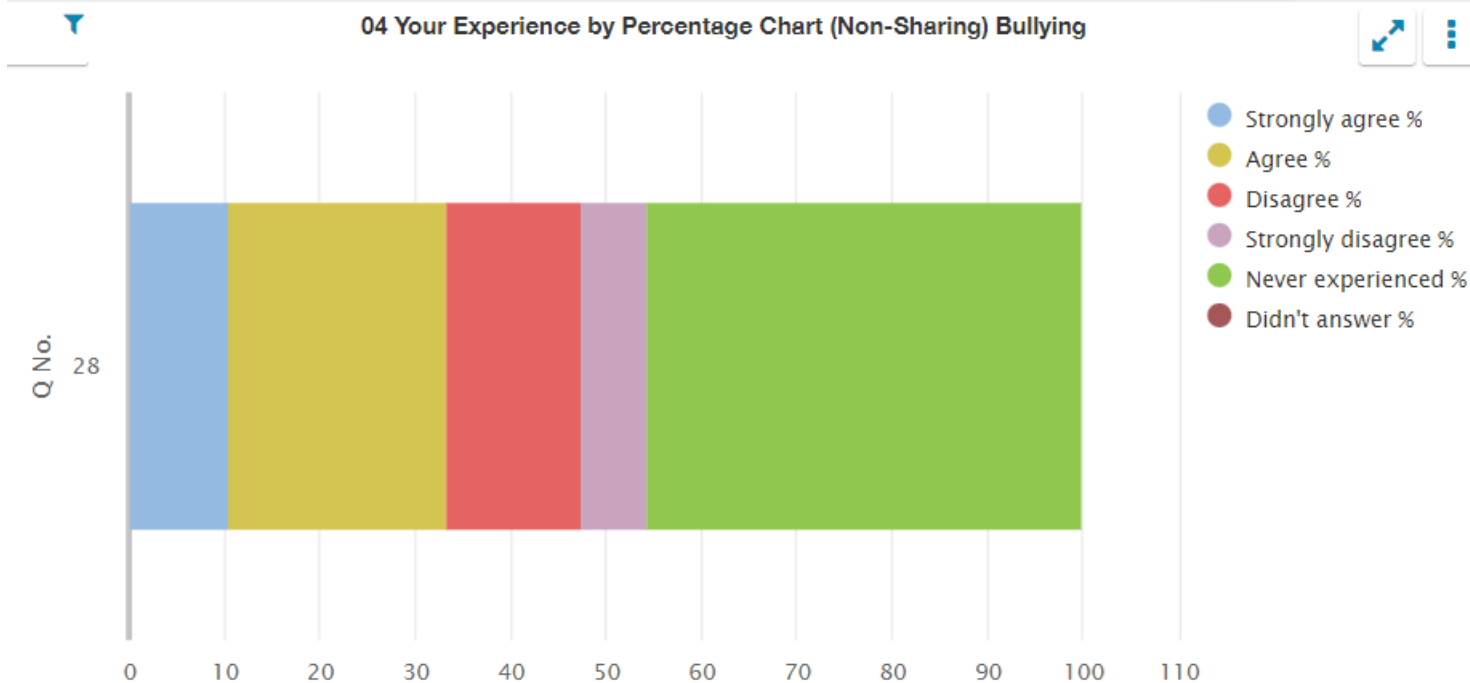

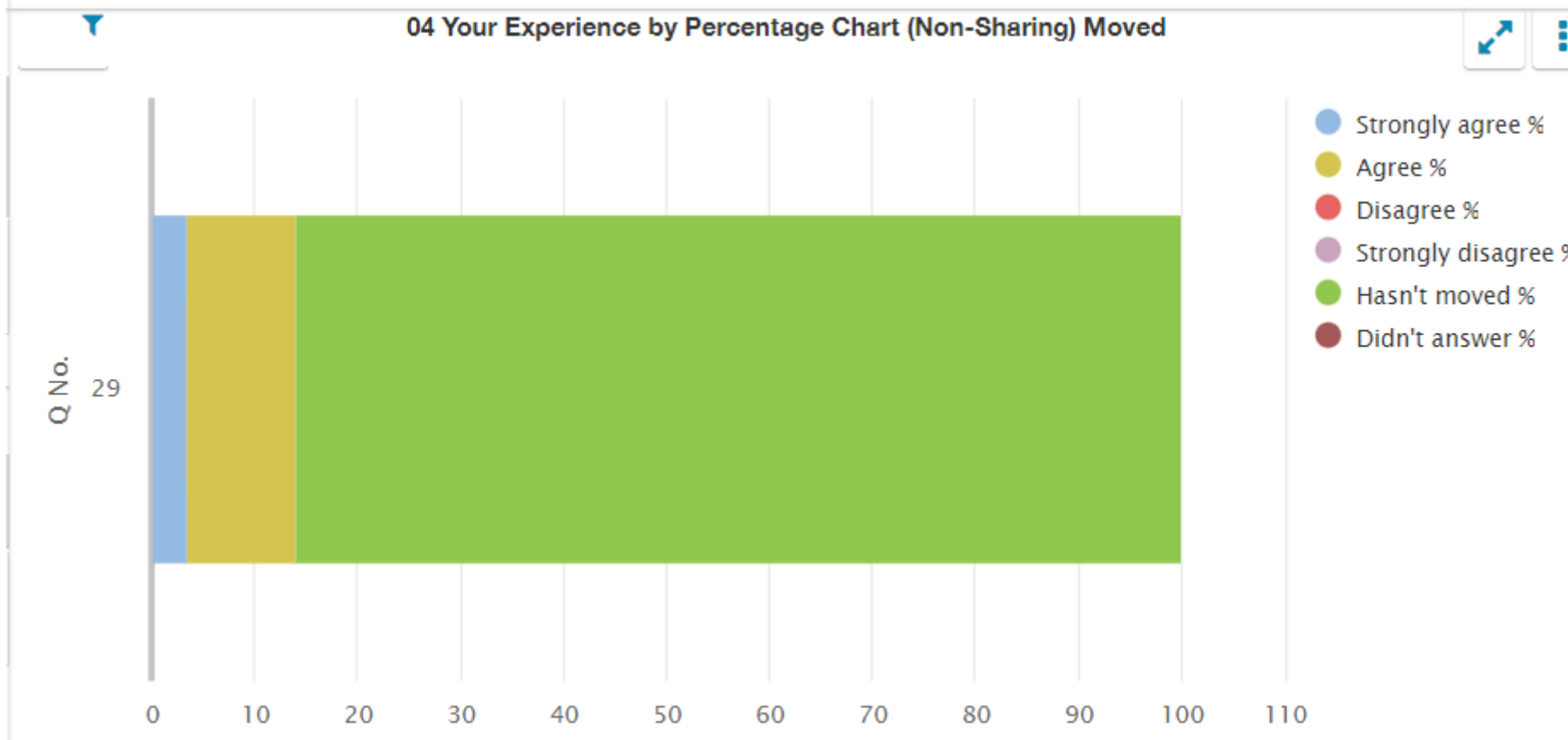
04 Your experience by percentage chart (sharing) bullying

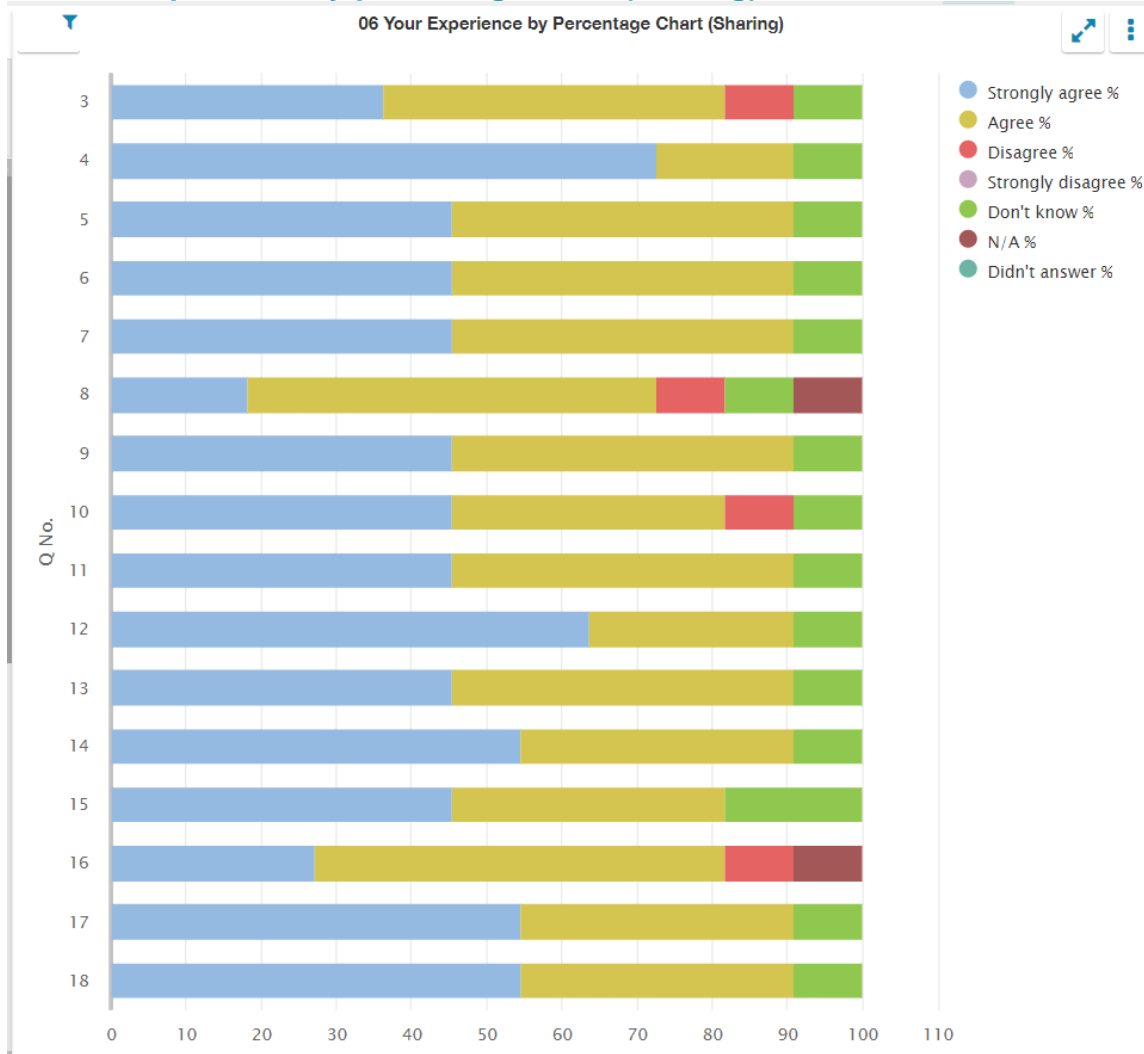
