## Dear Parent/Carer

In October 2024, a team of inspectors from Education Scotland visited Kinlochbervie High School. During our visit, we talked to parents/carers and young people and worked closely with the headteacher and staff.

The inspection team found the following strengths in the school's work.

- The headteacher led the revised vision and values for the school. These reflect the commitment of the school to improving outcomes for all young people. The revised values are relevant and meaningful for young people and have improved the culture and ethos within the school.
- There are good relationships between young people and staff. Young people learn in well-resourced, caring environments.
- Senior leaders have developed a wide range of helpful partnerships. These enable
  young people to access a wide range of activities and experiences beyond the
  school setting which helps young people develop relevant and appropriate skills.

The following areas for improvement were identified and discussed with the headteacher and a representative from The Highland Council.

- Senior leaders need to improve the strategic leadership of the school. This includes in learning, teaching and assessment, wellbeing and inclusion and in raising attainment for all young people.
- Senior leaders and teachers need to identify and implement the features of high-quality learning and teaching. They need to understand fully the role of assessment, and monitoring young people's progress. They also need to increase expectations of what all young people can achieve.
- All staff need to understand fully the statutory duties relating inclusion, wellbeing and equality. This will help them to understand better their roles and responsibilities in meeting the needs of all young people. This includes improving their awareness of inclusive practices to ensure that all young people feel valued and included.
- Across the school, young people need to have higher aspirations and attain and achieve more in line with their peers in similar schools across Scotland.



We gathered evidence to enable us to evaluate the school's work using four quality indicators from How good is our school? (4th edition). Quality indicators help schools, local authorities and inspectors to judge what is working well and what needs to be improved. Following the inspection of each school, the Scottish Government gathers details of our evaluations to keep track of how well Scottish schools are doing.
