Dear Parent/Carer

In November 2019, a team of inspectors from Education Scotland visited Strathmiglo Primary School and Nursery Class. During our visit, we talked to parents/carers and children and worked closely with the headteacher and staff.

The inspection team found the following strengths in the school's work.

- Children across the school are motivated, enthusiastic and articulate. Staff provide high
 quality feedback about their learning in literacy and numeracy. As a result, children know
 what they are good at and what they need to do to improve.
- Across the school and nursery, the headteacher and staff have created a positive learning environment. Supportive and respectful relationships contribute to a nurturing ethos where the views of children are valued.
- Staff and children ensure that the school is an integral part of the village. Children
 contribute very well to improving the local community and involving residents in the life of
 the school.
- Children in the school benefit from well-planned learning and teaching opportunities within
 interesting contexts. As a result, they are attaining very well and have a thorough
 understanding of the relevance of their learning. Children are making good links between
 the skills they are developing and how they will use them beyond school.

The following areas for improvement were identified and discussed with the headteacher and a representative from Fife Council.

- Across the school and nursery, staff and practitioners should continue to improve how they assess the progress children are making. They should make better use of assessment information to plan learning.
- Staff in the school and nursery need to develop a curriculum rationale that identifies what children will learn as they progress through the school and nursery.
- Staff in the school should support children to use what they are learning to make healthy
 choices and develop a better understanding of their own wellbeing.
- The headteacher and practitioners should continue to ensure there is a clear strategy for taking forward improvements in the nursery. Practitioners should support children to gain a better understanding of their own learning.



We gathered evidence to enable us to evaluate the school's work using four quality indicators from How good is our school? (4th edition) and How good is our early learning and childcare?. Quality indicators help schools, local authorities and inspectors to judge what is working well and what needs to be improved. Following the inspection of each school, the Scottish Government gathers details of our evaluations to keep track of how well Scottish schools are doing.
