# Corporate Parenting in the Professional Standards for Teachers

SPR 1: Demonstrating a commitment to supporting learners who are experiencing or who have experienced trauma, children and young people from a care experienced background and understanding responsibilities as a corporate parent.

'Teachers are cited by young people as the most influential or constant person in their lives.'

#### What we need you to do...

- Care for the learner
- Take an interest in them...get to know their needs
- Understand barriers to learning that they may have, and plan to meet them
- Believe in them ... keep going when things get challenging
