Dear Parent/Carer

In October 2023, a team of inspectors from Education Scotland visited Broughton Primary School and Nursery Class. During our visit, we talked to parents/carers and children and worked closely with the headteacher and staff.

The inspection team found the following strengths in the school's work.

- The friendly and welcoming environment in the school and nursery. There are positive relationships between all members of the school community. All staff are caring and considerate in their interactions with children. Children feel safe, happy and looked after.
- The respectful, settled and polite children in the school and nursery. They listen
 attentively to staff and to each other. They are keen to engage and co-operate well when
 playing and learning.
- The high quality learning experiences in the nursery indoor environment. The staff team in the nursery are successfully helping children to make good progress in their learning.

The following areas for improvement were identified and discussed with the headteacher and a representative from Scottish Borders Council.

- Improve approaches to leadership of change in the school and nursery. The headteacher needs to ensure that key improvement priorities are identified through robust selfevaluation and addressed in a rigorous manner.
- Improve the overall quality of learning and teaching in the school to meet better all children's needs. This will help to raise attainment in literacy and numeracy across the school.
- Improve approaches to planning learning and teaching in the school. Teachers need to
 plan learning for individuals and groups of children across all curricular areas. In doing
 so, they should plan tasks and activities which are appropriately matched to all children's
 level of ability.
- Improve approaches to assessment within the school. Teachers need to gather stronger and more relevant assessment evidence to support planning for learning that meets all children's needs.



We gathered evidence to enable us to evaluate the school's work using four quality indicators from How good is our school? (4th edition) and How good is our early learning and childcare?. Quality indicators help schools, local authorities and inspectors to judge what is working well and what needs to be improved. Following the inspection of each school, the Scottish Government gathers details of our evaluations to keep track of how well Scottish schools are doing.
