Dear Parent/Carer

In January 2025, a team of inspectors from Education Scotland and the Care Inspectorate visited Antonine Primary School and Nursery Class. During our visit, we talked to parents/carers and children and worked closely with the headteacher and staff.

The inspection team found the following strengths in the school's work.

- The highly positive ethos and culture in the school and nursery, based firmly on the school vision, values and children's rights. All staff work collaboratively, supporting children to be confident, happy learners who feel they are an important part of their school community.
- The strong leadership of the headteacher and senior leaders who have developed effective processes for successful school and nursery improvement. They support and encourage all staff and children to lead and contribute positively to the life and work of the school and nursery.
- Staff, across the school and nursery, place the health and wellbeing of children at the heart of their work and have created highly inclusive learning environments. They identify and address children's wellbeing needs very well which enables children to engage successfully in their learning.
- Children across the school and nursery make very good progress in their learning. They have a wide range of opportunities to contribute to the life and work of the school, achieve success and develop new skills.

The following areas for improvement were identified and discussed with the headteacher and a representative from Falkirk Council.

- Continue, as planned to implement school and nursery improvement priorities to support all children to achieve their best.
- In the school, continue to develop approaches to consistent high-quality learning, teaching and assessment.
- In the nursery, continue to provide further opportunities for children to be involved in improvement planning.





We gathered evidence to enable us to evaluate the school's work using four quality indicators from How good is our school (4th edition) and How good is our early learning and childcare?. Quality indicators help schools, local authorities and inspectors to judge what is working well and what needs to be improved.
