## Dear Parent/Carer

In April 2025, a team of inspectors from Education Scotland and the Care Inspectorate visited Allan's Primary School and Nursery Class. During our visit, we talked to parents/carers and children and worked closely with the headteacher and staff.

The inspection team found the following strengths in the school's work.

- The inspirational and strategic leadership of the headteacher ably supported by the
  extended leadership team. She leads by example and sets very high standards for all.
  The headteacher has created extremely successfully a dynamic culture of continuous
  improvement in the school and nursery that is improving effectively children's
  experiences.
- The motivated, inclusive and respectful children in the school and nursery. They
  contribute confidently and positively through leadership opportunities to improve the
  learning experiences of all children. This is having a very positive impact on outcomes for
  children and supports them to make very good progress in their learning.
- The proactive and creative leadership demonstrated by all staff across the school and nursery. They work extremely well together as an enthusiastic and skilled team to provide high quality experiences for children.
- The extensive range of approaches used highly successfully to support and promote the
  wellbeing and inclusion of all children and their families. All staff have embedded these
  fully into their daily practices. This is ensuring that children's individual needs are not a
  barrier to improving their outcomes.
- The creative and engaging way staff across the school and nursery deliver learning.
   Children benefit from highly developed approaches such as outdoor learning, learning through play and learning that connects well, different areas of the curriculum. As a result, children receive high-quality, stimulating learning experiences which motivate and engage them very successfully.
- The high-quality interactions between practitioners and children in the nursery. Staff skilfully support, extend and challenge children's learning through a very effective blend of adult-initiated and child-led experiences. This is helping children to be confident and thrive in their environment.

The following areas for improvement were identified and discussed with the headteacher and a representative from Stirling Council.

In the nursery, senior leaders should streamline how they gather, collate and interpret the
wide range of data available. This will increase further the pace of change across the
nursery.





In the primary school, senior leaders should continue to develop their approaches to assessing children's progress across all curricular areas and stages of the school. This will provide increased clarity of children's progress in all curricular areas throughout their time in school.





We gathered evidence to enable us to evaluate the school's work using four quality indicators from How good is our school (4th edition) and How good is our early learning and childcare?. Quality indicators help schools, local authorities and inspectors to judge what is working well and what needs to be improved. Following the inspection of each school, the Scottish Government gathers details of our evaluations to keep track of how well Scottish schools are doing.
