Dear Parent/Carer

In May 2019, a team of inspectors from Education Scotland and the Care Inspectorate visited Crosshouse Primary School, Communication centre and Early Childhood Centre. During our visit, we talked to parents/carers and children and worked closely with the headteacher and staff.

The inspection team found the following strengths in the school's work.

- The highly effective leadership of the headteacher who is very well respected by children, staff and parents. She has enabled the creation of a strong collaborative culture across the school. Together with the depute head teacher and principal teacher, senior leaders provide very strong guidance for all stakeholders. There is a very clear focus on continued improvement for all the children at Crosshouse Primary School.
- The very positive relationships and supportive learning environment provided by staff in the early childhood centre, across the primary school and in the communication centre. This is resulting in children being well-motivated in class. Children are very friendly, polite and proud of their school. They are beginning to play an increasing role in leading and assessing their own learning and the learning of others.
- There is a calm, purposeful and nurturing climate for learning in the early childhood centre and across the primary school and communication centre. Children are valued greatly and work well within an ethos of respect. Children support each other well within this highly inclusive school environment. Staff demonstrate well their approaches to valuing and celebrating diversity. There is a clear focus on the dignity and worth of individuals and a result children demonstrate very high levels of empathy towards each other across the whole school.
- The very strong commitment from local community partners to widen learning experiences for all children. This is enriching greatly the quality of their learning and supporting the development of their achievements.

The following areas for improvement were identified and discussed with the headteacher and a representative from East Ayrshire Council.

- Staff should continue to work together to ensure consistency in the provision of high quality learning and teaching across the early childhood centre, the primary school and the communication centre. This includes the need to increase pace and challenge. Learners need to be more aware of their targets, the skills they are developing and what they need to do to improve further.
- In the early childhood centre and across the primary school, senior leaders should proceed as planned to put in place, further strategies to secure continuing progress.
  Together with the children, staff should focus on evaluating progress and improvement





over time more regularly. This will support learners to work at the correct pace and with sufficient challenge and support.

We gathered evidence to enable us to evaluate the school's work using four quality indicators from <u>How good is our school? (4<sup>th</sup> edition)</u> and <u>How good is our early learning and childcare?</u>. Quality indicators help schools, local authorities and inspectors to judge what is working well and what needs to be improved. Following the inspection of each school, the Scottish Government gathers details of our evaluations to keep track of how well Scottish schools are doing.
