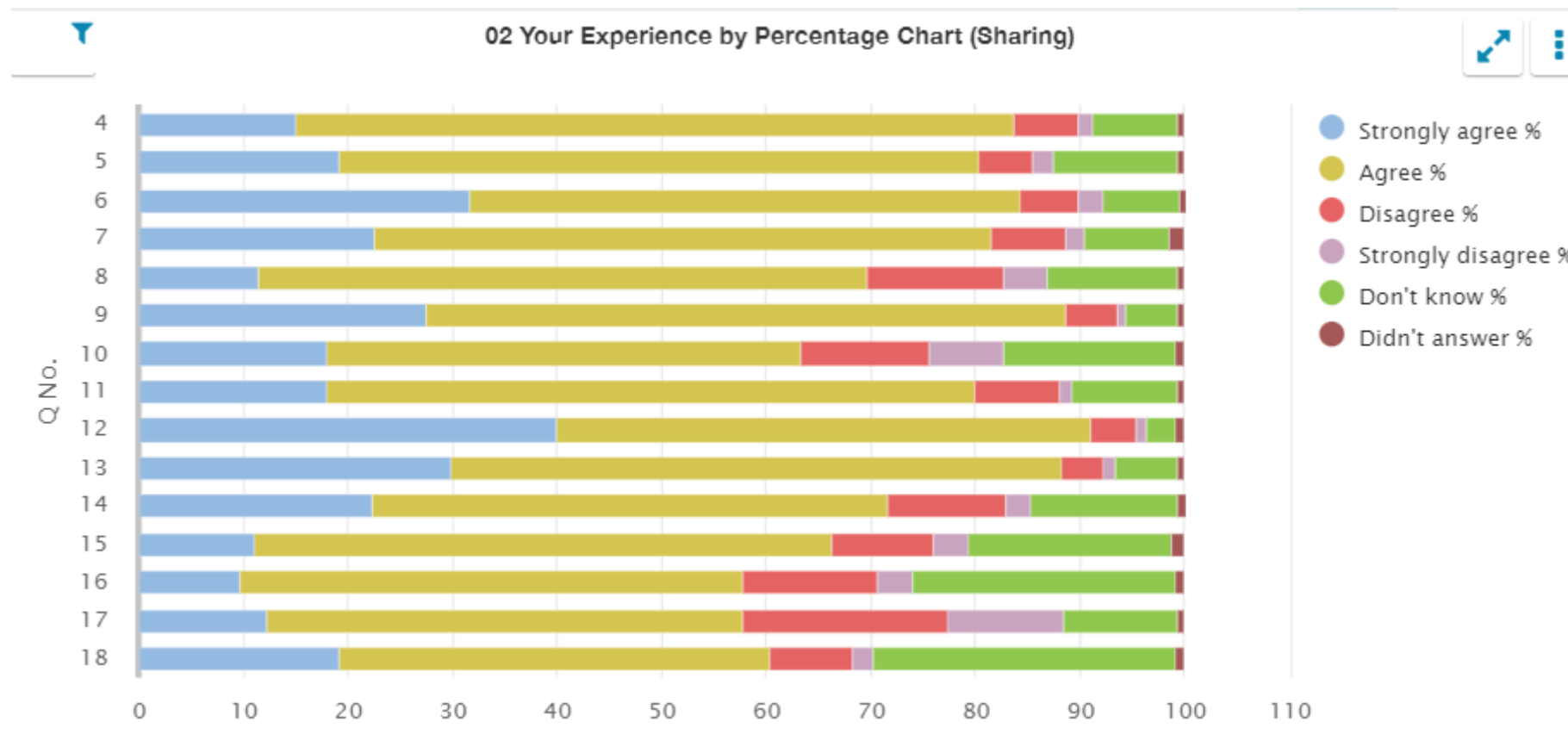

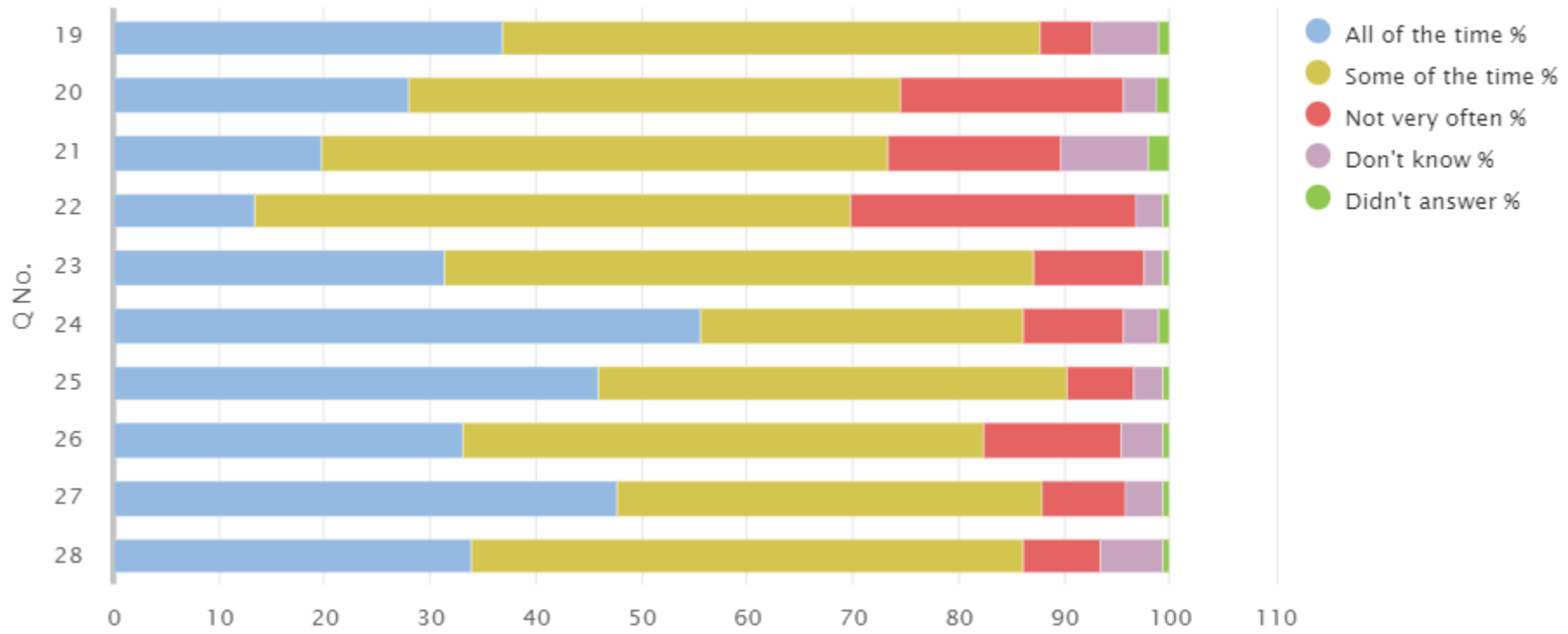

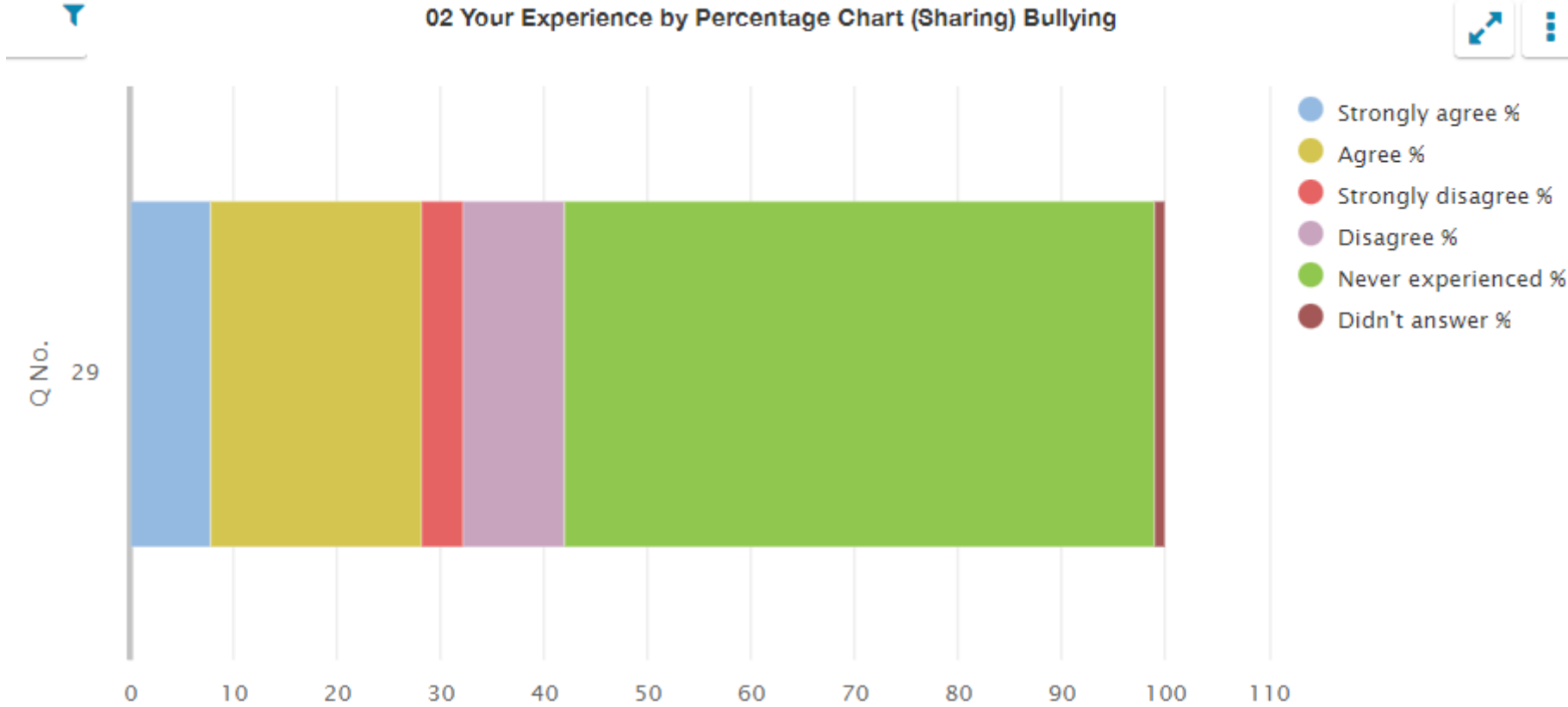
02 Your Experience by Percentage 2 Chart (Sharing)

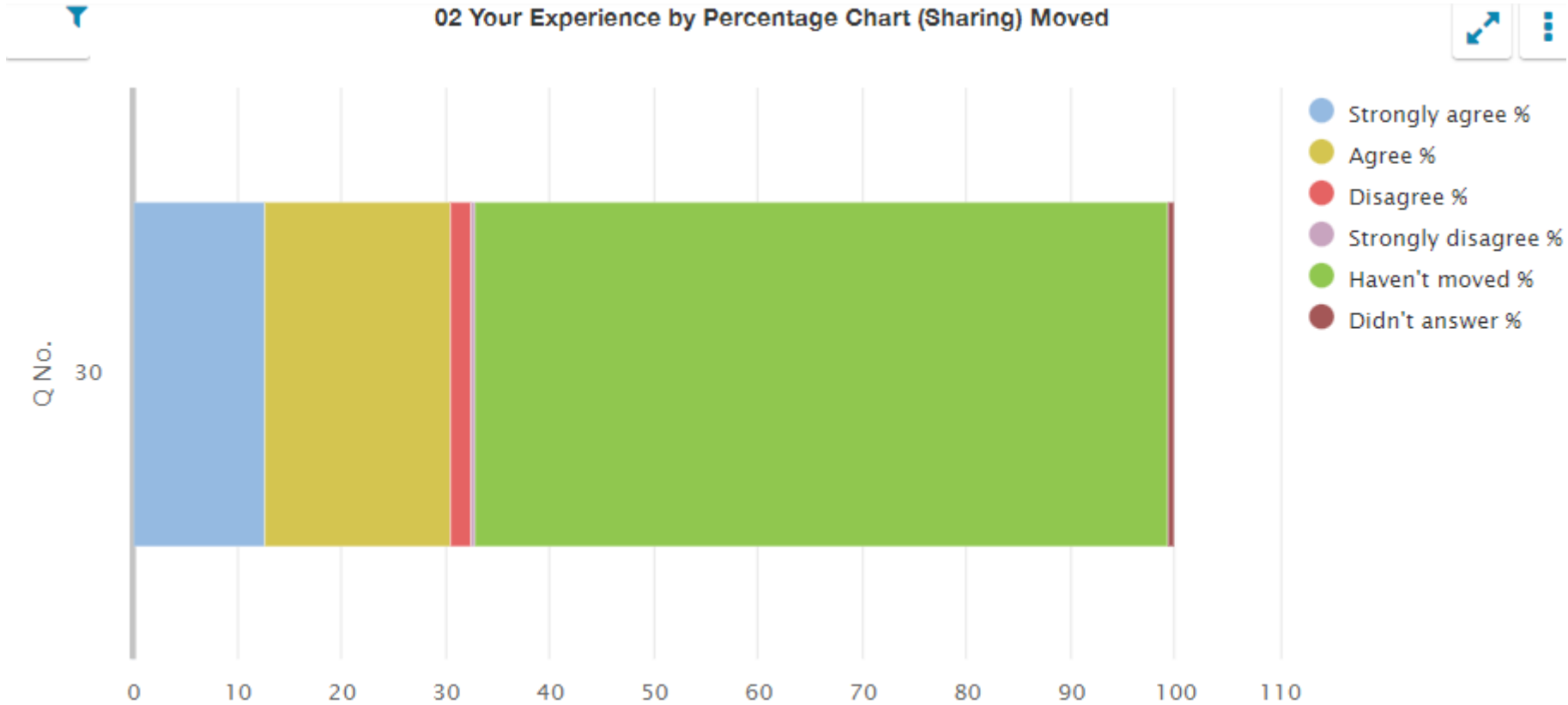

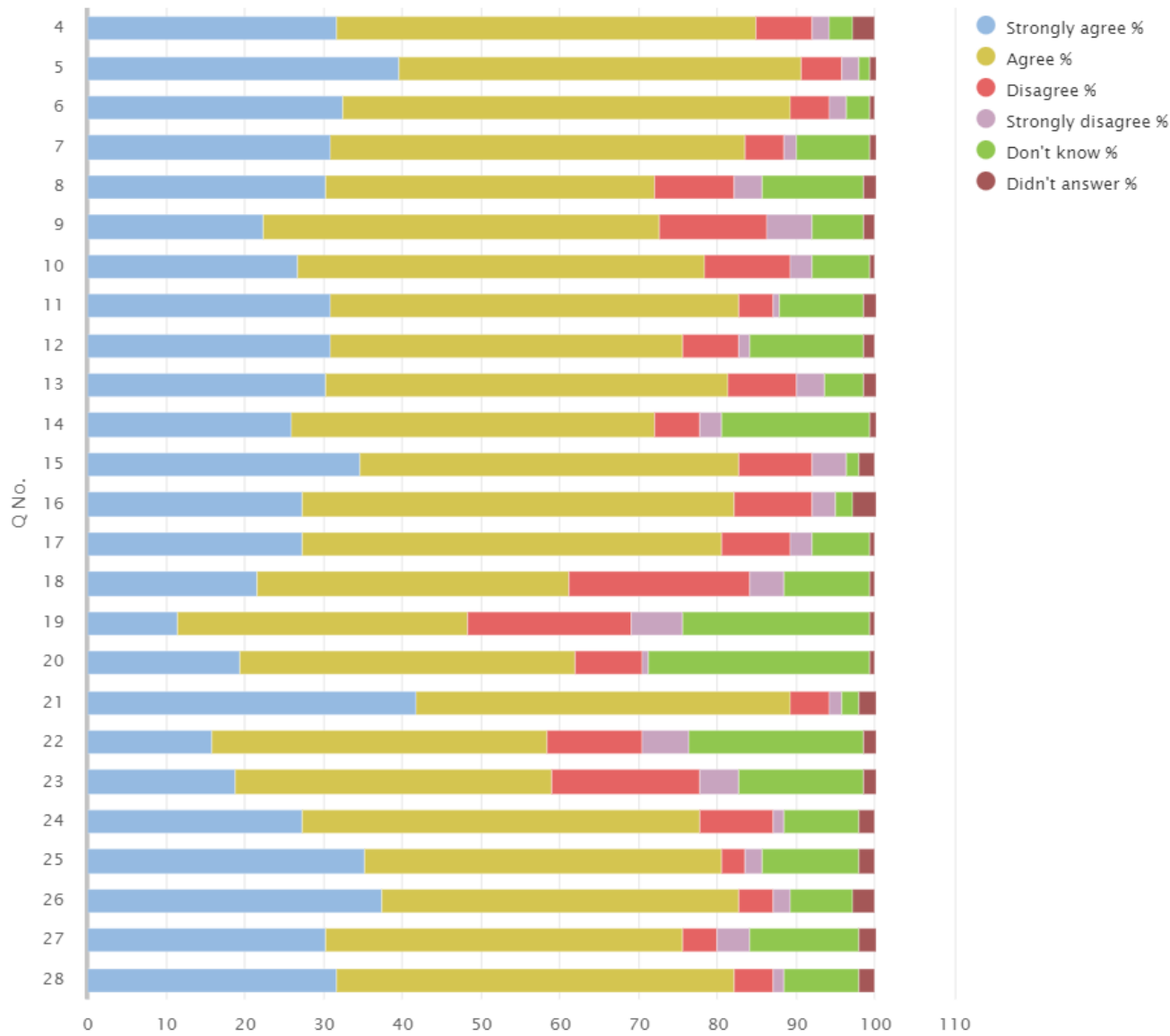

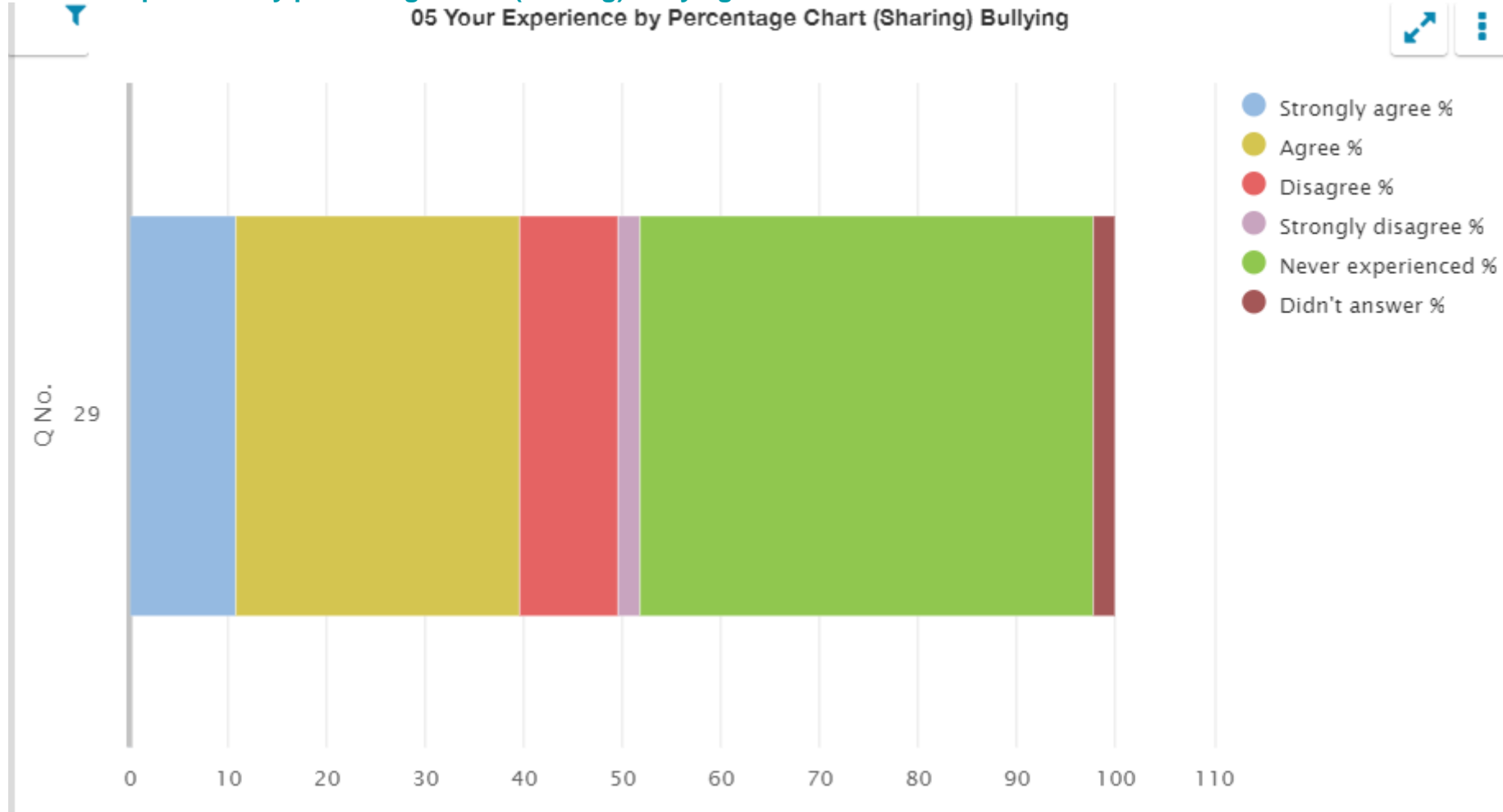
05 Your Experience by Percentage Chart (Sharing)

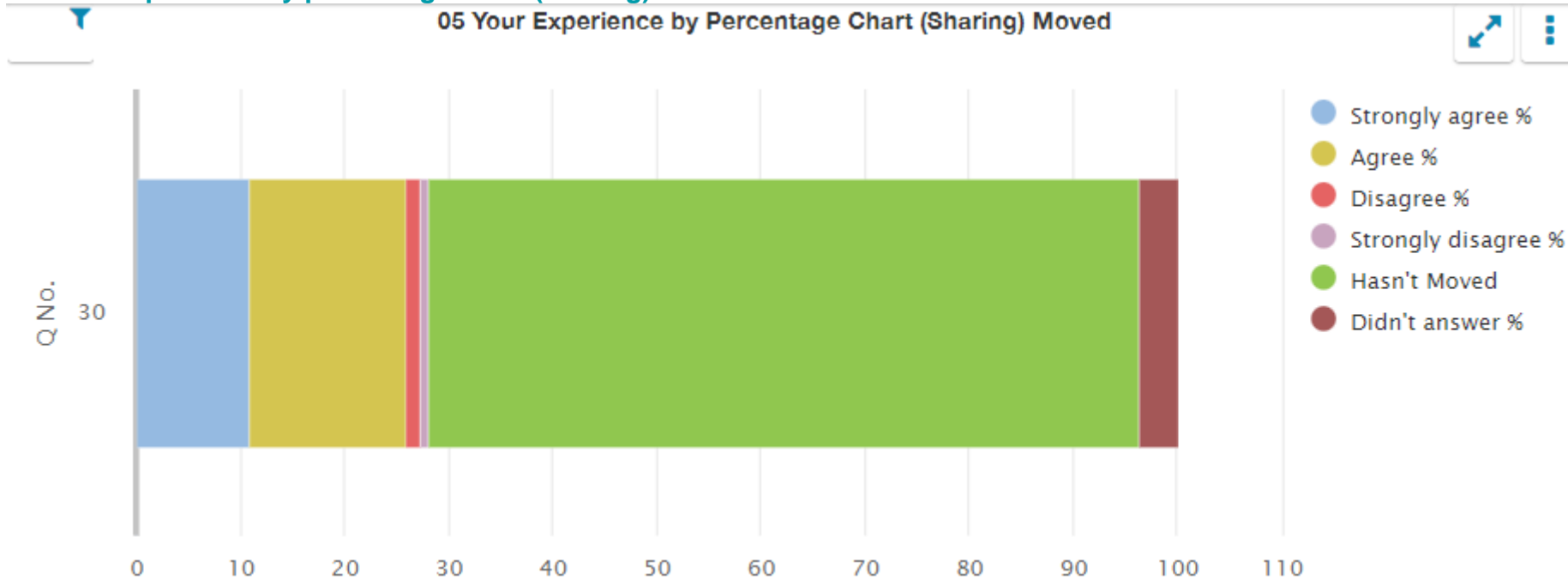
05 Your experience by percentage chart (sharing) bullying

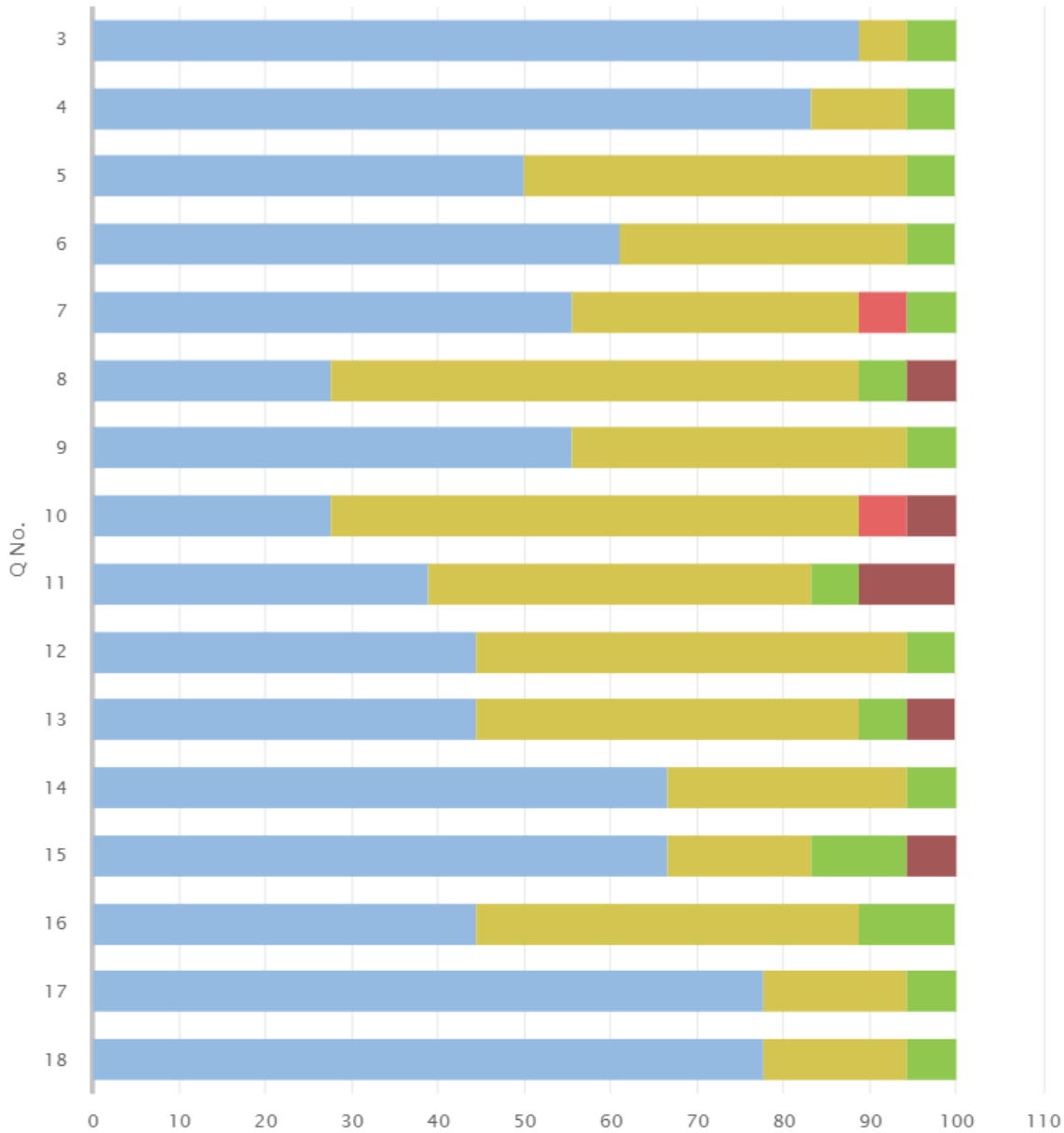

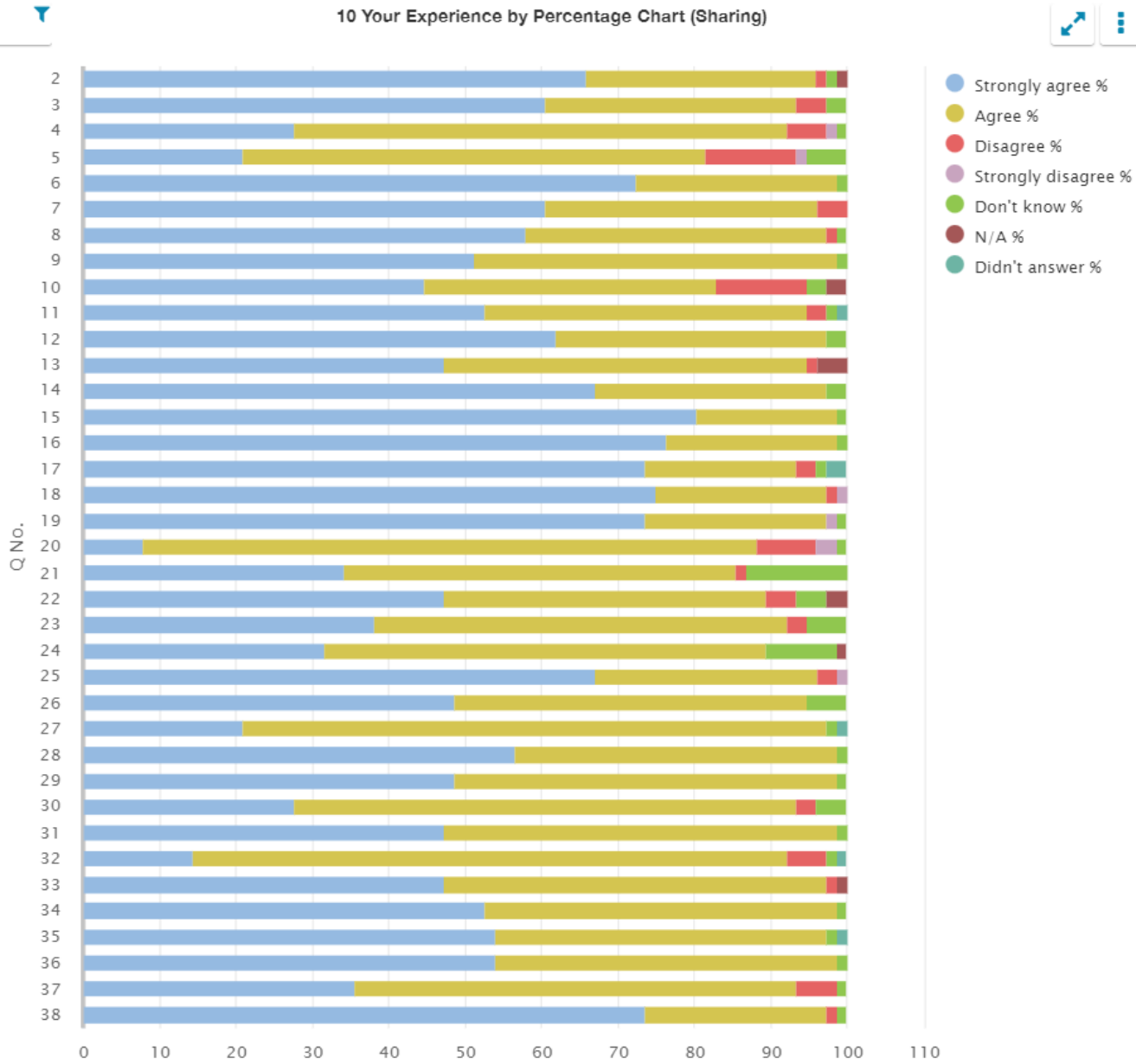
