Dear Parent/Carer

In October 2018, a team of inspectors from Education Scotland and the Care Inspectorate visited Tealing Primary School and Nursery Class. During our visit, we talked to parents/carers and children and worked closely with the headteacher and staff.

The inspection team found the following strengths in the school's work.

- The positive start the headteacher has made in his short time in post and the way he has engaged staff, children, parents and the community
- Happy, polite children who are eager to learn.
- The good relationships between staff and children across the school and nursery class.

The following areas for improvement were identified and discussed with the headteacher and a representative from Angus Council

- To raise attainment for all children, revise approaches to planning learning and teaching to develop further assessment and moderation. This should include robust tracking and monitoring of children's progress in their learning and wider achievements.
- Develop consistent approaches to learning and teaching ensuring an appropriate level of pace and challenge. This should include developing a progressive curriculum that is relevant, meets the needs of learners, and supports children to develop skills across all curriculum areas.
- In the nursery class, continue to build upon children's involvement in planning and leading their own learning.





We gathered evidence to enable us to evaluate the schools work using four quality indicators from <u>How good is our school? (4th edition)</u> and <u>How good is our early learning and childcare?</u>. Quality indicators help schools, local authorities and inspectors to judge what is working well and what needs to be improved. Following the inspection of each school, the Scottish Government gathers details of our evaluations to keep track of how well Scottish schools are doing.
