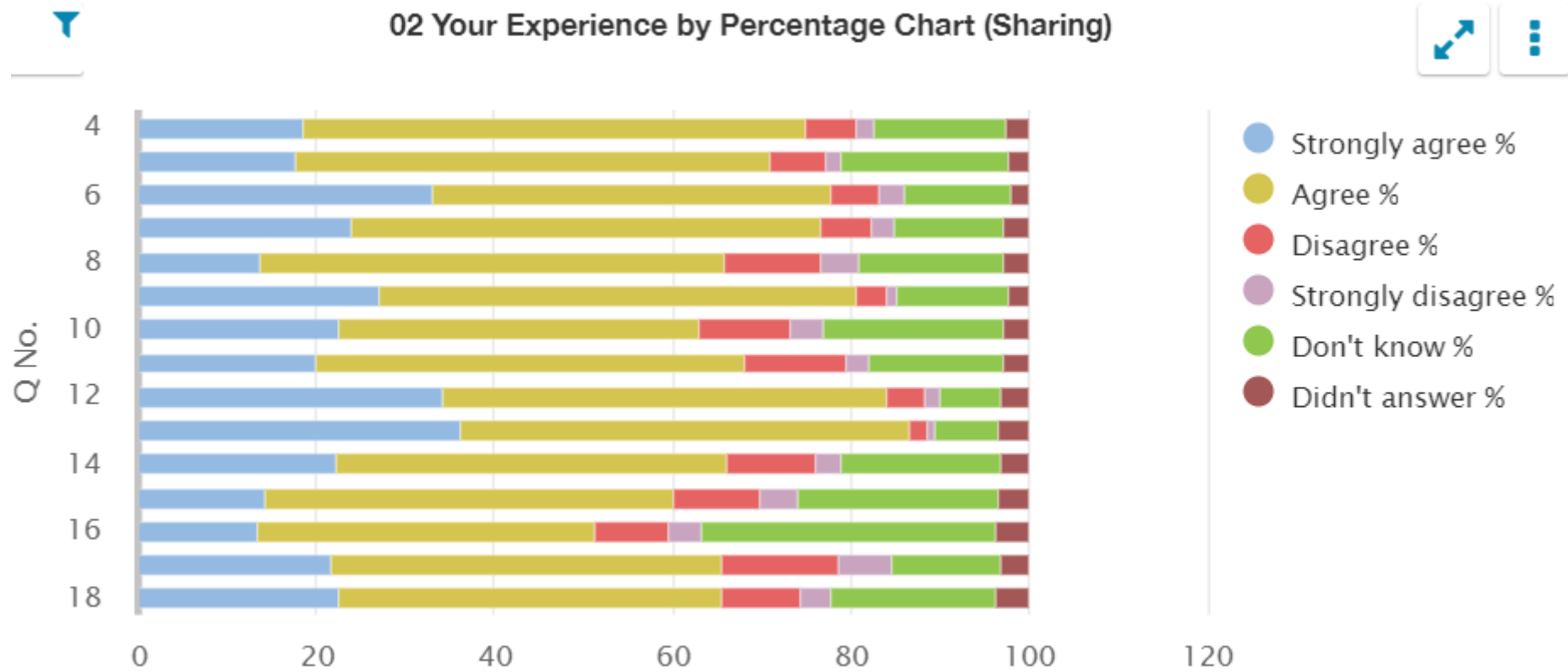

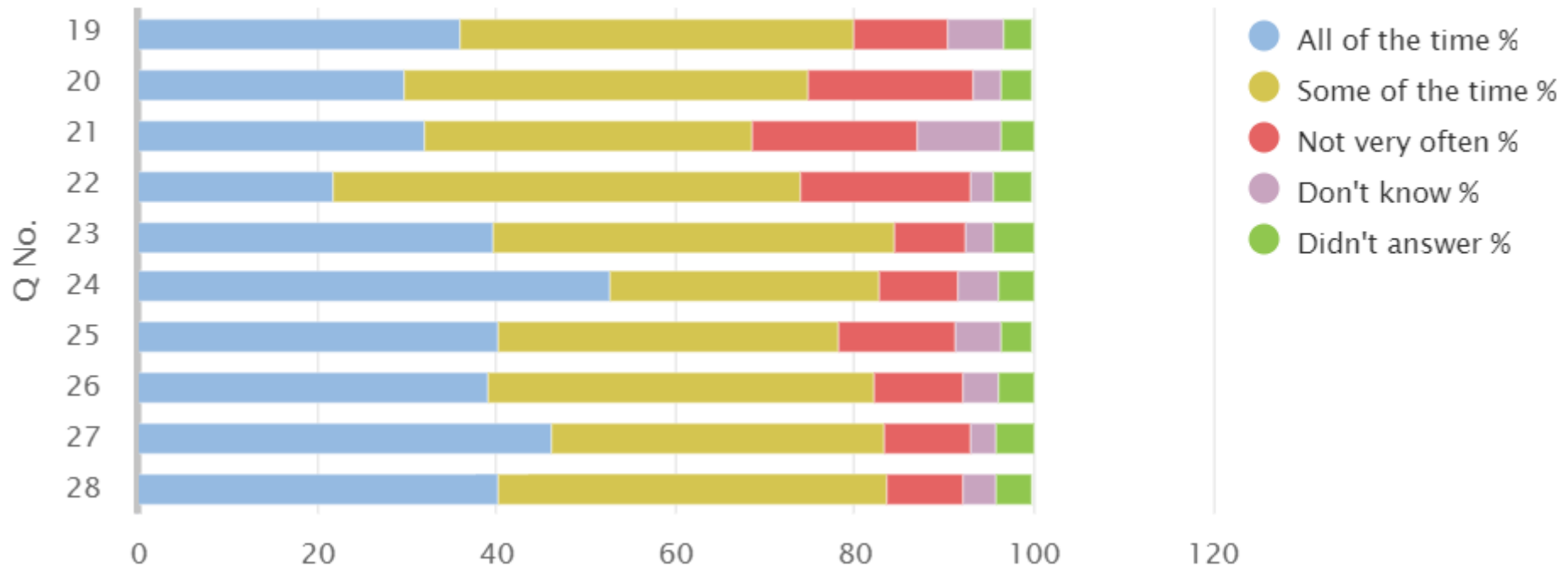

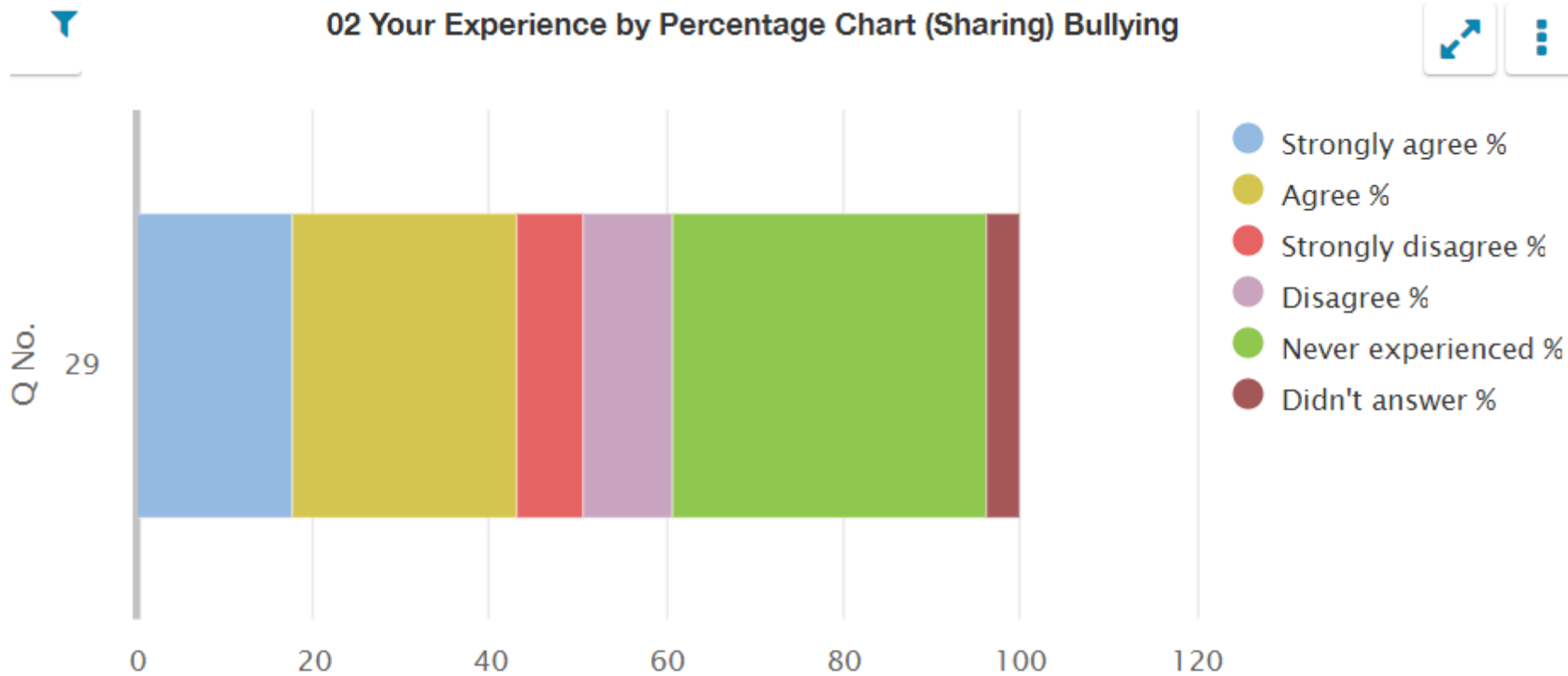
02 Your Experience by Percentage 2 Chart (Sharing)

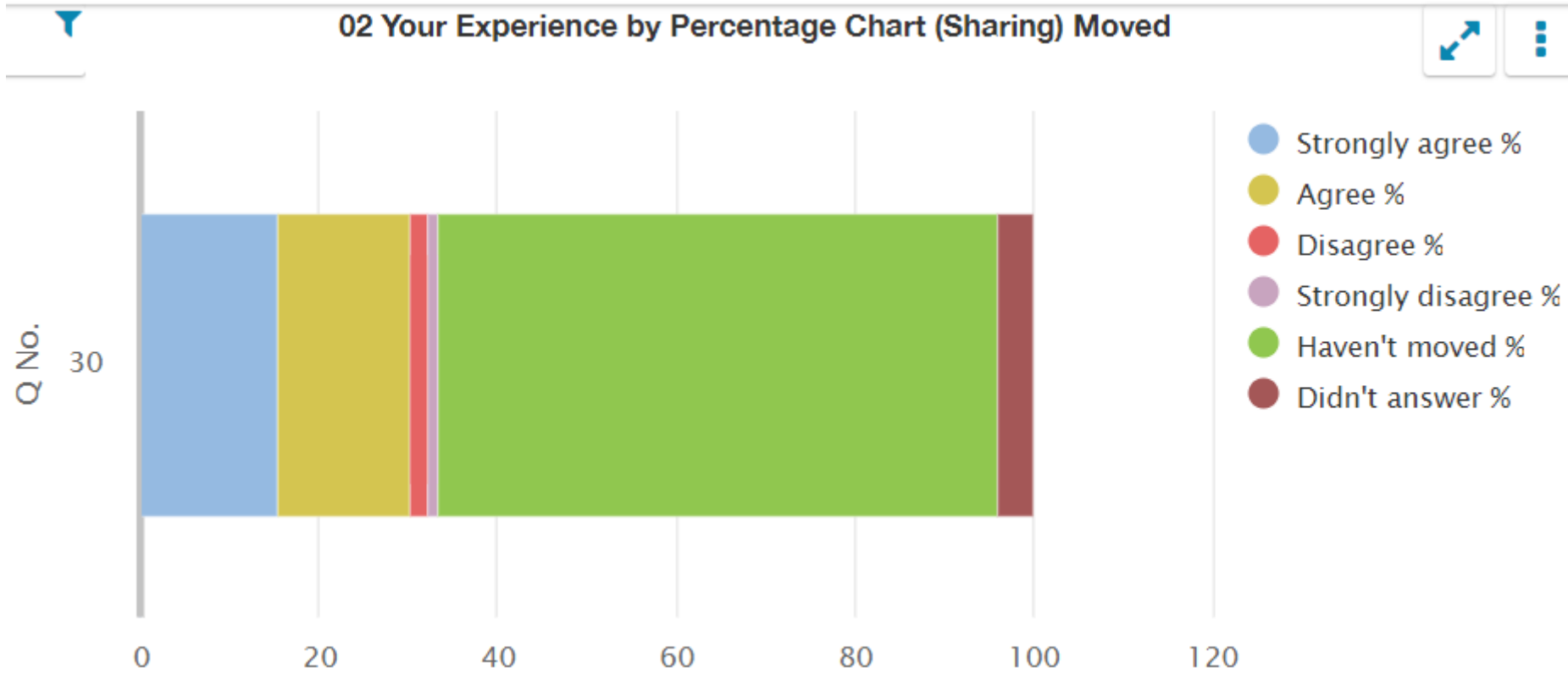
02 Your experience by percentage chart (sharing) bullying

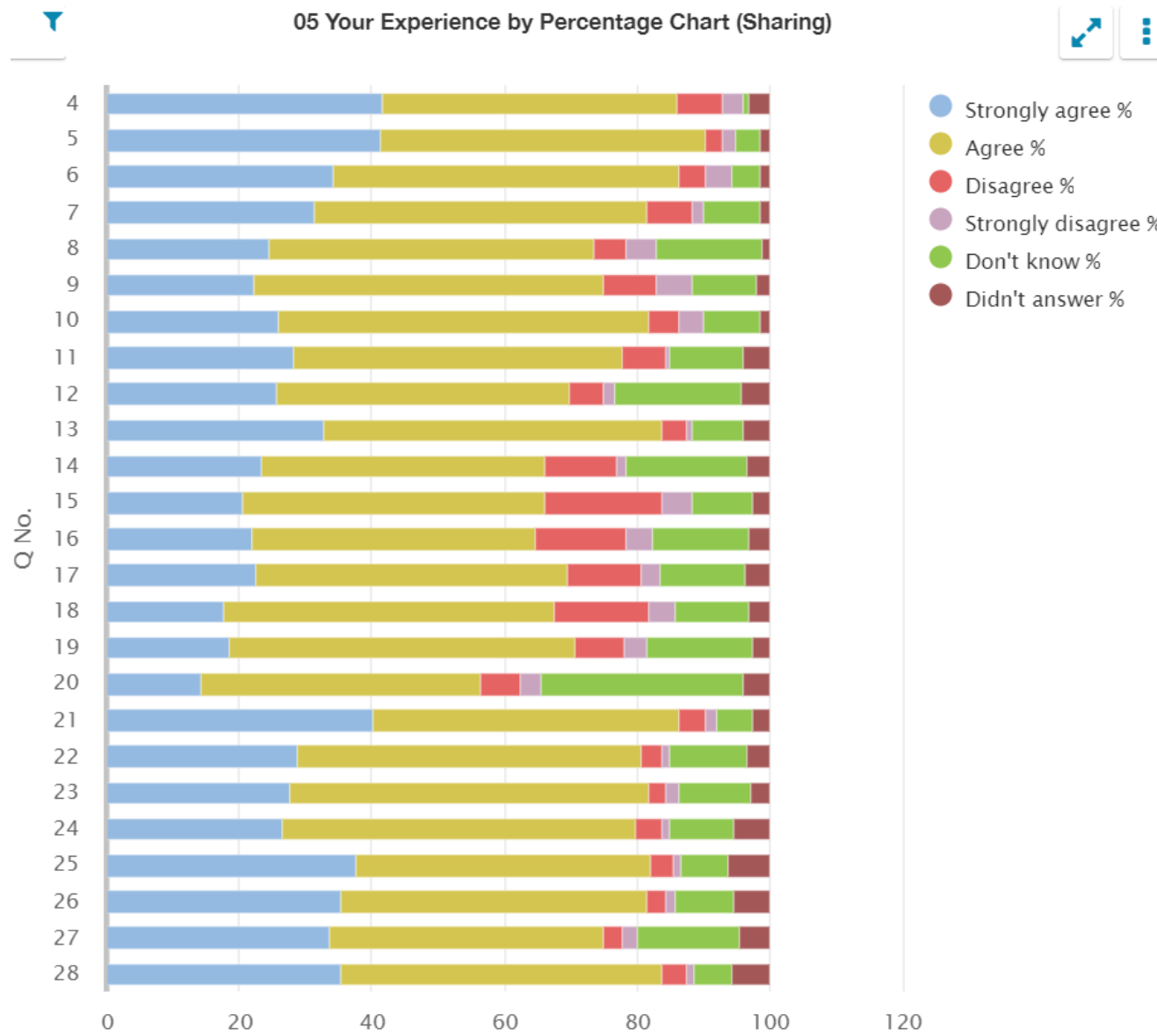

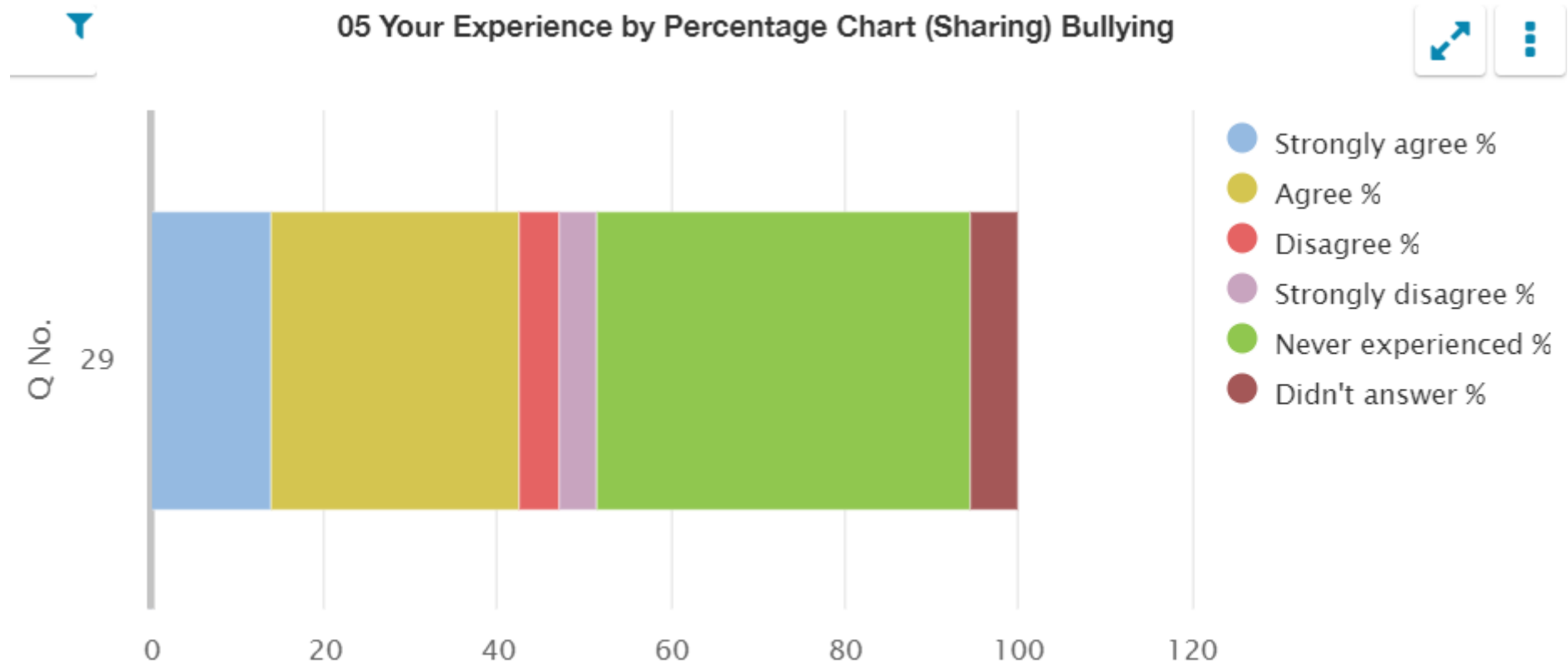

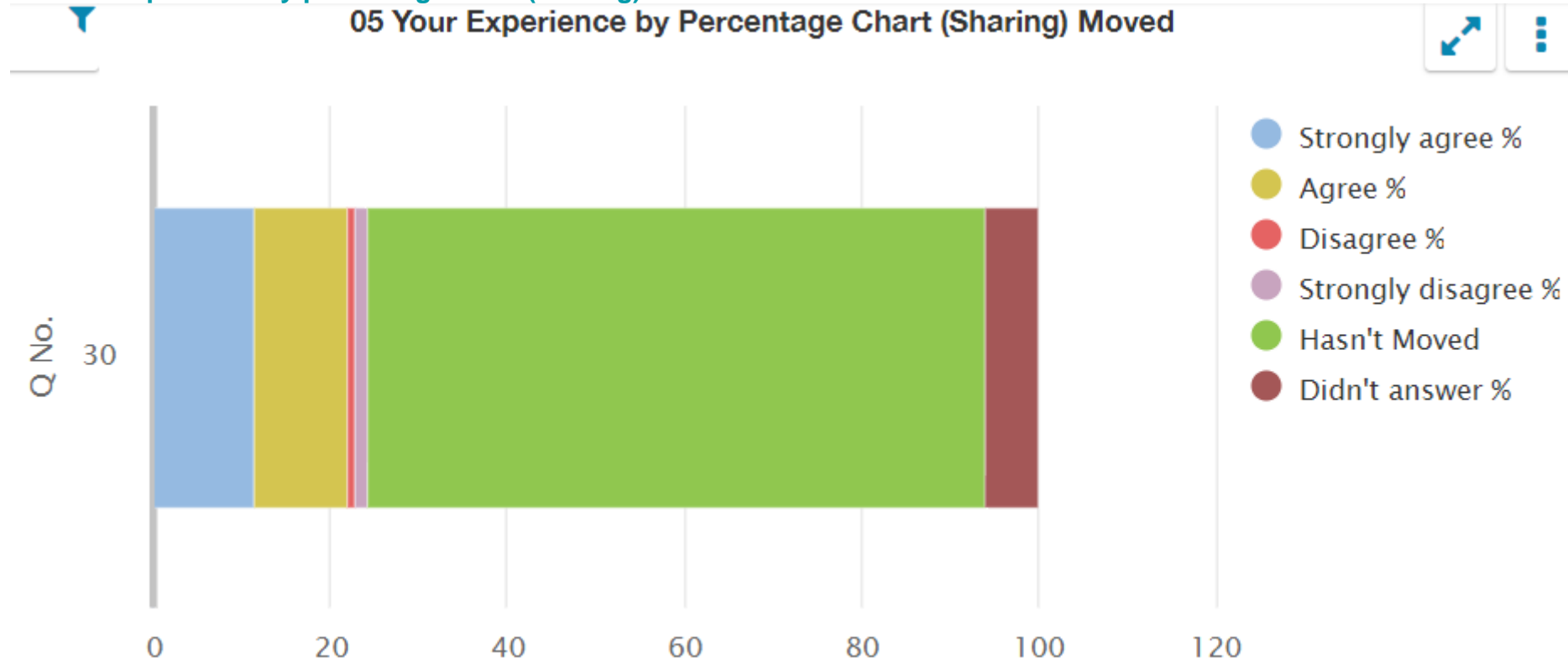
05 Your experience by percentage chart (sharing) bullying

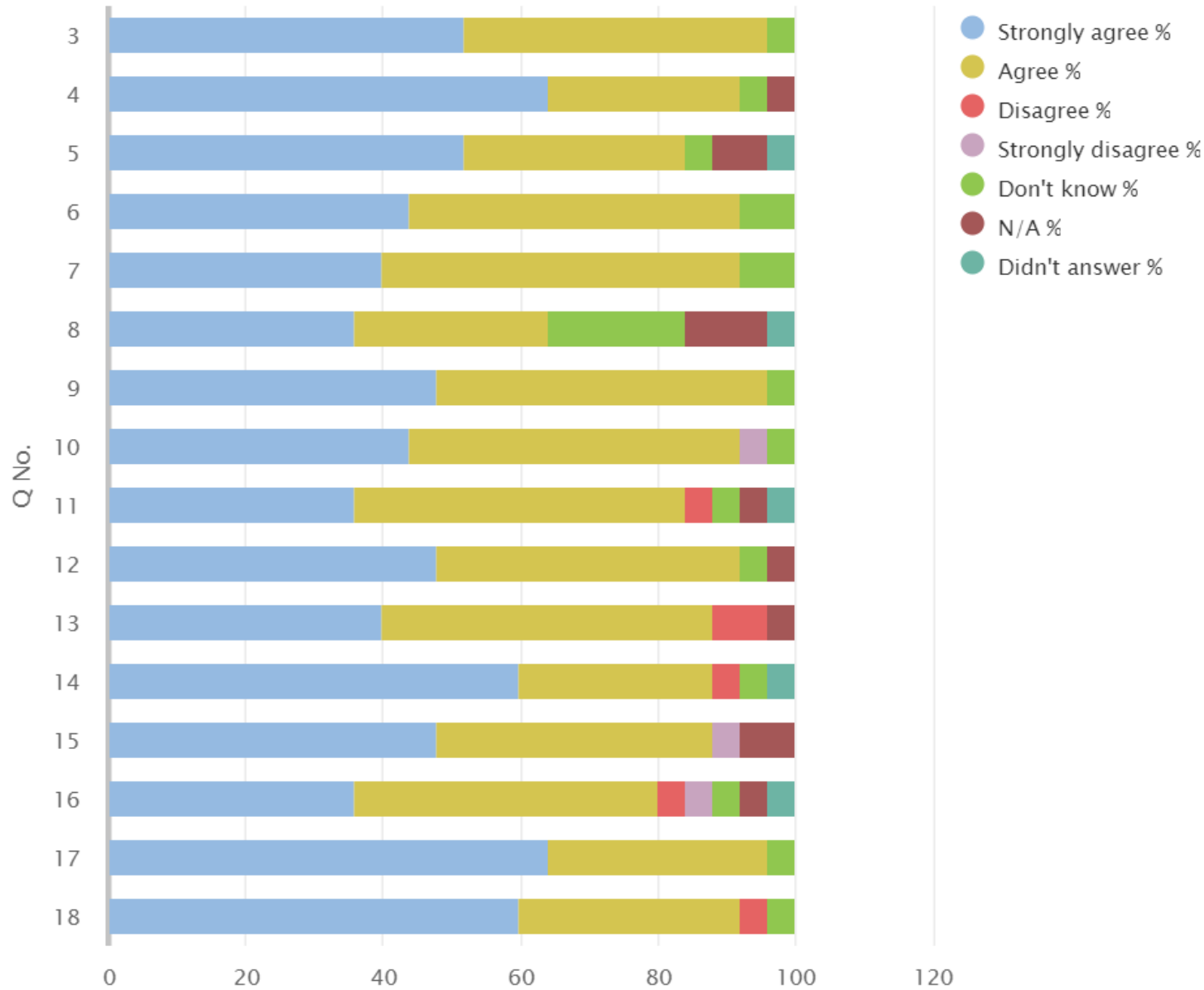

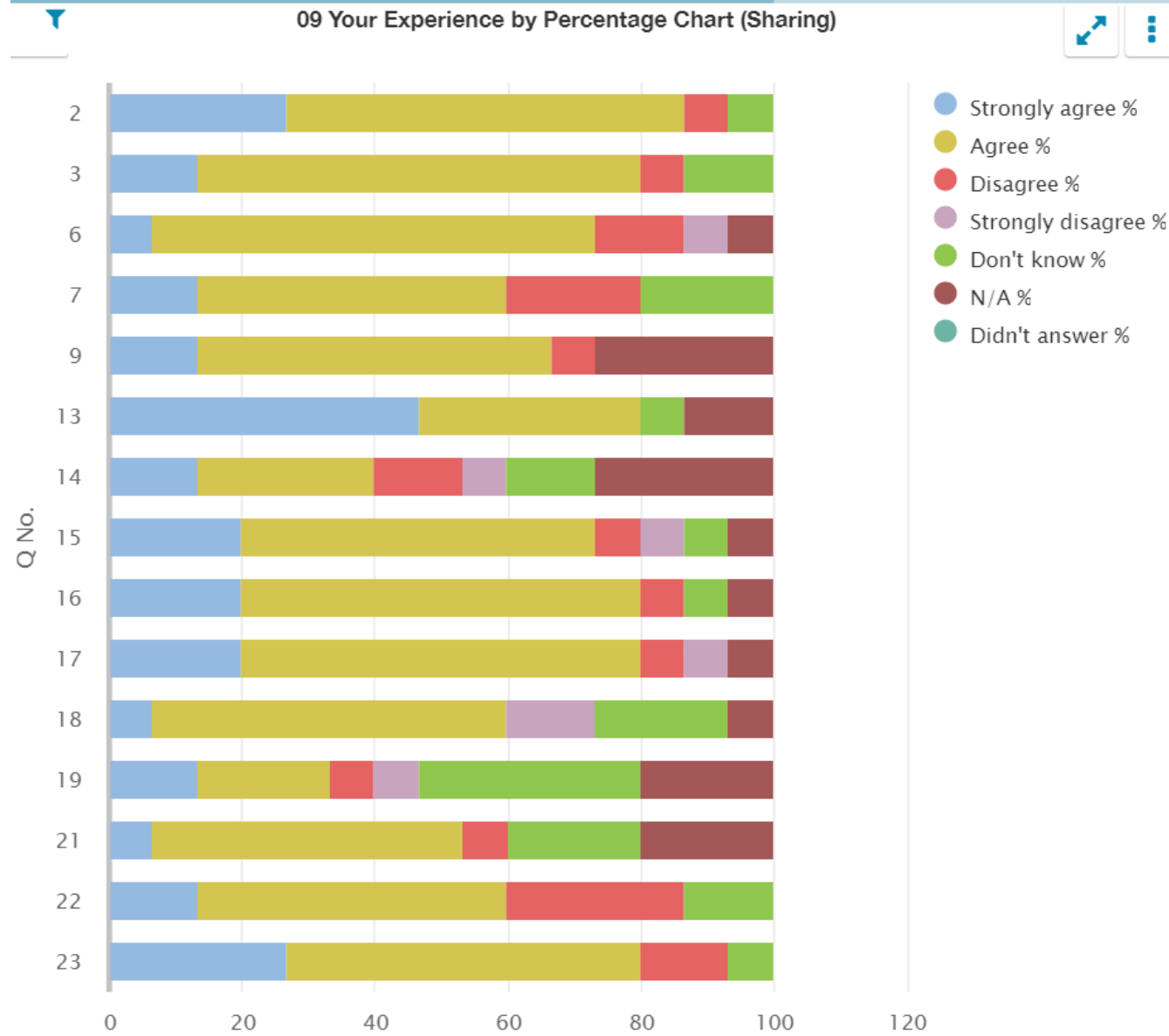

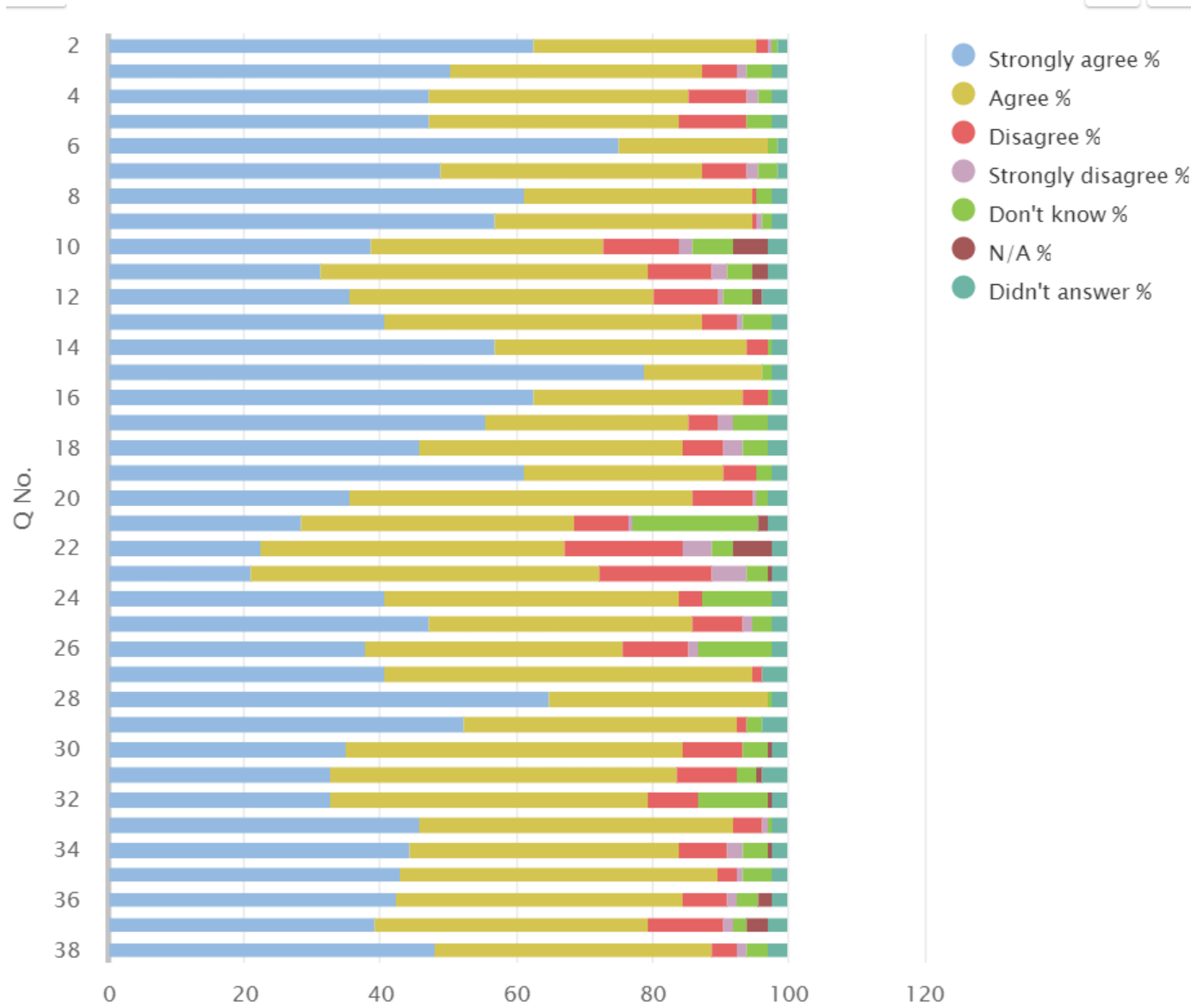
