Eligibility	Applications are invited from practitioners in early learning and childcare settings or schools/clusters/associated school groups across Scotland. NB: We will accept one application per establishment. School clusters may apply for more than £3000 and should provide clear detail in the application as to how this will be spent across the cluster. Note - ASN schools in the independent sector are also eligible to apply for funding.

Overview

In Kilmacolm Primary School and Nursery Class we are very fortunate to have fantastic school grounds and a huge outdoor learning space. In previous sessions, there was a sensory garden and nursery vegetable patch. However, during a year long decant, the garden has become overgrown and many of the plants have not survived. In October 2016, the school and nursery came back together in our refurbished building.

'Let's Grow and Cook Together' Project

The school project 'Let's Grow and Cook Together' will involve all 230 children from the nursery class and primary school along with parents, carers, local businesses and local community groups.

Key aims of the project are to:

1. fully utilise the school outdoor learning space to create a sustainable garden area to grow fruit, vegetables and herbs whilst developing children's gardening skills
2. create a school cooking classroom to develop the children's hygiene and food technology skills
3. work with local community groups to use their expertise, knowledge and guidance to develop the garden and a cooking classroom
4. develop staff skills and knowledge to enable them to confidently deliver the Experiences and Outcomes in Food Technology and Health Education
5. improve the quality of Food Education with learning across the curriculum (HWB, Literacy, Numeracy and Science)
6. ensure that Outdoor Learning and Food Education become embedded in the school curriculum
7. fully engage with the whole school community through our extremely active Twitter accounts (school and class accounts, we will use the hashtags #KPSLovesGardening and #KPSLovesCooking), the school website, newsletters, the local press and a community event at the end of the session (Kilmacolm Garden Party)
8. develop the children's awareness of the seasons and an understanding of food production by creating a seasonality calendar, that will be used as a teaching resource in years to come
9. organise a Kilmacolm Garden Party to showcase all the knowledge and skills developed by the children

Business Partnerships

- Scottish & Southern Electricity Networks (SSE) supported the school in April 2017 by tidying our growing spaces in the garden. SSE will continue this support and by providing 'man power' to help with any other gardening work that is needed eg to create raised beds.
- Central Building Contractors (CBC) were the contractors for the school decant. They have committed to giving us some financial support to provide the school with gardening equipment for the project.

Community Partnerships

- Johanna and Alda Clark from the Cross Cafe in Kilmacolm and Jackie Dunn (school catering manager) will support the school in an advisory role by developing the staff and the children's hygiene and food technology skills
- Royal Horticultural Society, Kilmacolm Horticultural Society and the local 'Branching Out' project will support the school in an advisory role to help develop the sustainable garden area by developing the staff and children's gardening knowledge and skills
- The school Parent Partnership will support the project by providing parent/carer helpers to work alongside the children in the garden and in the cooking classroom
- Jean McCredie, Home Economist will support the project by advising on the creation of recipes using the produce grown in the garden (the produce will be showcased and sold at the Kilmacolm Garden Party)

Evaluation of the Project

- The Kilmacolm Garden Party will be the showcase of how the Health and Wellbeing, Literacy, Numeracy and Science experiences and outcomes have fully been embedded in the school curriculum.
- Each class (including the nursery class) will be responsible for creating a recipe and produce to be sold at the Kilmacolm Garden Party. Stalls will be set up, the children will be able to talk about their experience during the project, demonstrating their knowledge and skills. All profits will be used to fund a future project in session 2018/19.
- We strongly believe that the skills developed in this first year will allow the pupils to further gain confidence in their own learning and be able to identify the next steps in developing the project in session 2018/19.
